

AMENDMENT TO H. RES. 668
OFFERED BY MR. GARCIA OF CALIFORNIA

Add at the end the following:

1 **SEC. 4. PRODUCTION OF DOCUMENTS TO THE COMMITTEE**
2 **ON OVERSIGHT AND GOVERNMENT REFORM.**

3 (a) DOCUMENTS PRODUCED BY THE DEPARTMENT
4 OF JUSTICE.—

5 (1) On August 5, 2025, Pamela J. Bondi, At-
6 torney General of the United States, was duly served
7 with a subpoena to produce a set of materials pos-
8 sessed by the Department of Justice and related to
9 Jeffrey Epstein and Ghislaine Maxwell and their en-
10 gagement in human trafficking, exploitation of mi-
11 nors, sexual abuse, and other related activity, to the
12 Committee on Oversight and Government Reform of
13 the House of Representatives in Washington, D.C.

14 (2) On August 22, 2025, the Department of
15 Justice produced to the Committee on Oversight and
16 Government Reform of the House of Representatives
17 a set of documents related to Jeffrey Epstein and
18 Ghislaine Maxwell that do not encompass the en-
19 tirety of materials in the possession of the Depart-

1 ment of Justice and sought by the subpoena, and
2 were previously made public through other avenues.

3 (3) The set of materials possessed by the De-
4 partment of Justice is material and necessary in
5 order that the House of Representatives may prop-
6 erly execute the functions imposed on it and may ob-
7 tain information necessary as a basis for such legis-
8 lative and other action as the House of Representa-
9 tives may deem necessary and proper.

10 (4) Attorney General Pamela J. Bondi has
11 failed to produce the complete set of materials
12 sought by the Committee on Oversight and Govern-
13 ment Reform in disobedience of the subpoena.

14 (b) SUBPOENA COMPLIANCE.—If Attorney General
15 Pamela J. Bondi fails to produce to the Committee on
16 Oversight and Government Reform the entirety of the ma-
17 terials in possession of the Department of Justice sought
18 by the subpoena issued on August 5, 2025, within 30 days
19 of the enactment of this resolution—

20 (1) Attorney General Pamela J. Bondi shall be
21 deemed to be in contempt of the House of Rep-
22 resentatives for disobeying the August 5, 2025, sub-
23 poena; and

24 (2) the Speaker of the House of Representa-
25 tives shall impose a fine, which may not be paid with

1 appropriated funds, on Attorney General Pamela J.
2 Bondi of \$10,000 per day, until such time as Attor-
3 ney General Bondi complies with the subpoena of
4 the House of Representatives.
