

**AMENDMENT TO RULES COMMITTEE PRINT 119-**

**33**

**OFFERED BY MR. GARCÍA OF ILLINOIS**

At the end of subtitle F of title X, insert the following new section:

1 **SEC. 10\_\_\_. OVERSIGHT OF THE PROCUREMENT OF EQUIP-**  
2 **MENT BY STATE AND LOCAL GOVERNMENTS**  
3 **THROUGH THE DEPARTMENT OF DEFENSE.**

4 Section 281 of title 10, United States Code, is  
5 amended—

6 (1) by redesignating subsection (d) as sub-  
7 section (f); and

8 (2) by inserting after subsection (e) the fol-  
9 lowing new subsections:

10 “(d) LIMITATIONS ON PURCHASES.—(1) The Sec-  
11 retary may not facilitate the purchase of the following  
12 under this section:

13 “(A) Controlled firearms, ammunition, bayo-  
14 nets, grenade launchers, grenades (including stun  
15 and flash-bang), and explosives.

16 “(B) Controlled vehicles, highly mobile multi-  
17 wheeled vehicles, mine-resistant ambush-protected

1 vehicles, trucks, truck dump, truck utility, and truck  
2 carryall.

3 “(C) Drones that are armored, weaponized, or  
4 both.

5 “(D) Controlled aircraft that—

6 “(i) are combat configured or combat  
7 coded; or

8 “(ii) have no established commercial flight  
9 application.

10 “(E) Silencers.

11 “(F) Long-range acoustic devices.

12 “(G) Items in the Federal Supply Class of  
13 banned items.

14 “(2) The Secretary shall require, as a condition of  
15 any purchase of equipment under this section, that if the  
16 Department of Justice opens an investigation into a State  
17 or unit of local government for any violation of civil lib-  
18 erties, the Secretary shall pause all pending or future pur-  
19 chases by that State or unit of local government.

20 “(3) The Secretary shall prohibit the purchase of  
21 equipment by a State or unit of local government for 10  
22 years upon a finding that equipment purchased under this  
23 section by the State or unit of local government was used  
24 as part of any violation of civil liberties.

1       “(e) PUBLICLY ACCESSIBLE WEBSITE ON PUR-  
2 CHASED EQUIPMENT.—(1) The Secretary, in coordination  
3 with the Administrator of General Services, shall establish  
4 and maintain a publicly available internet website that  
5 provides up-to-date and comprehensive information, in a  
6 searchable format, on the purchase of equipment under  
7 the procedures established under subsection (a) and the  
8 recipients of such equipment.

9       “(2) The information required to be made publicly  
10 available under paragraph (1) includes all unclassified in-  
11 formation pertaining to such purchases, including—

12               “(A) the catalog of equipment available for pur-  
13 chase under subsection (e);

14               “(B) for each purchase of equipment under the  
15 procedures established under subsection (a)—

16                       “(i) the recipient State or unit of local gov-  
17 ernment;

18                       “(ii) the purpose of the purchase;

19                       “(iii) the type of equipment;

20                       “(iv) the cost of the equipment; and

21                       “(v) the administrative costs under sub-  
22 section (b); and

23               “(C) other information the Secretary deter-  
24 mines is necessary.

1           “(3) The Secretary shall update the information in-  
2 cluded on the internet website required under paragraph  
3 (1) on a quarterly basis.”.
