At the end of title VII, add the following new section:

1	SEC. 7 REPORT CONTAINING THREAT ASSESSMENT
2	ON TERRORIST USE OF CONVENTIONAL AND
3	ADVANCED CONVENTIONAL WEAPONS.
4	(a) Report Required.—Not later than 180 days
5	after the date of the enactment of this Act, and annually
6	thereafter for a period of 4 years, the Under Secretary
7	of Homeland Security for Intelligence and Analysis, in co-
8	ordination with the Director of the Federal Bureau of In-
9	vestigation, shall develop and submit to the entities in ac-
10	cordance with subsection (b) a report containing a threat
11	assessment regarding the availability of conventional
12	weapons, including conventional weapons lacking serial
13	numbers, and advanced conventional weapons, for use in
14	furthering acts of terrorism, including the provision of ma-
15	terial support or resources to a foreign terrorist organiza-
16	tion and to individuals or groups supporting or engaging
17	in domestic terrorism

1	(b) Dissemination of Report.—Consistent with
2	the protection of classified and confidential unclassified in-
3	formation, the Under Secretary shall—
4	(1) submit the initial report required under
5	subsection (a) to Federal, State, local, and Tribal
6	law enforcement officials, including officials who op-
7	erate within State, local, and regional fusion centers
8	under the Department of Homeland Security State,
9	Local, and Regional Fusion Center Initiative estab-
10	lished by section 210A of the Homeland Security
11	Act of 2002 (6 U.S.C. 124h); and
12	(2) submit each report required under sub-
13	section (a) to the appropriate congressional commit-
14	tees.
15	(c) Definitions.—In this section:
16	(1) Appropriate congressional commit-
17	TEES.—The term "appropriate congressional com-
18	mittees" means—
19	(A) the Permanent Select Committee on
20	Intelligence, the Committee on Homeland Secu-
21	rity, and the Committee on the Judiciary of the
22	House of Representatives; and
23	(B) the Select Committee on Intelligence,
24	the Committee on Homeland Security and Gov-

1	ernmental Affairs, and the Committee on the
2	Judiciary of the Senate.
3	(2) Domestic Terrorism.—The term "domes-
4	tic terrorism" has the meaning given that term in
5	section 2331 of title 18, United States Code.
6	(3) Foreign terrorist organization.—The
7	term "foreign terrorist organization" means an or-
8	ganization designated as a foreign terrorist organiza-
9	tion under section 219 of the Immigration and Na-



tionality Act (8 U.S.C. 1189).
