Page 322, after line 18, insert the following:

1 **SEC. 210. ST. MARY'S REINVESTMENT.**

2 (a) **SHORT TITLE.**—This section may be cited as the  
3 “St. Mary’s Reinvestment Act”.

4 (b) **DEFINITIONS.**—In this section:

5 (1) **SECRETARY.**—The term “Secretary” means  
6 the Secretary of the Interior, acting through the  
7 Commissioner of Reclamation.

8 (2) **ST. MARY CANAL REHABILITATION PHASE 1**  
9 **PROJECT.**—The term “St. Mary Canal Rehabilita-  
10 tion Phase 1 Project” means any activity associated  
11 with extraordinary maintenance (including scheduled  
12 or unscheduled replacement or rehabilitation) of the  
13 St. Mary Diversion Dam, Fish Screens, and St.  
14 Mary Canal Headwork within the St. Mary Storage  
15 Unit of the Milk River Project authorized by Con-  
16 gress on March 25, 1905.

17 (c) **AUTHORIZATION OF ST. MARY CANAL REHABILI-**  
18 **TATION PHASE 1 PROJECT.**—

1           (1) USE OF APPROPRIATED FUNDS.—The Sec-  
2           retary may use appropriated funds to carry out the  
3           St. Mary Canal Rehabilitation Phase 1 Project.

4           (2) PARTICIPATION OF BLACKFEET TRIBE.—  
5           The Secretary shall coordinate with the Blackfeet  
6           Tribe with respect to any replacement activities car-  
7           ried out under the St. Mary Canal Rehabilitation  
8           Phase 1 Project.

9           (3) COST-SHARING REQUIREMENT.—The Fed-  
10          eral share of the total cost of the St. Mary Canal  
11          Rehabilitation Phase 1 Project shall be 75 percent,  
12          which shall be nonreimbursable to the United States.

13         (d) AUTHORIZATION OF APPROPRIATIONS.—

14           (1) IN GENERAL.—Subject to adjustment under  
15           paragraph (2), there are authorized to be appro-  
16           priated to the Secretary for the period of fiscal years  
17           2022 through 2037, \$52,000,000 for the St. Mary  
18           Canal Rehabilitation Phase 1 Project.

19           (2) ADJUSTMENT OF AMOUNT.—The amount  
20           referred to in paragraph (1) may be increased or de-  
21           creased in accordance with ordinary fluctuations in  
22           development costs incurred after the date of enact-  
23           ment of this Act, as indicated by any available engi-  
24           neering cost indices applicable to construction activi-  
25           ties that are similar to the construction of the St.

1 Mary Canal Rehabilitation Phase 1 Project, as de-  
2 termined by the Secretary.

3 (e) OFFSET.—The St. Mary Diversion and Convey-  
4 ance Works project authorized under section 5103 of the  
5 Water Resources Development Act of 2007 (121 Stat.  
6 1234) is deauthorized.
