

AMENDMENT TO RULES COMMITTEE PRINT 119-8
OFFERED BY MR. GOLDMAN OF NEW YORK

At the end of subtitle D of title X add the following
new section:

1 **SEC. 10 ____ . DEPARTMENT OF DEFENSE TRAINING PRO-**
2 **GRAM ON ANTISEMITISM.**

3 (a) ESTABLISHMENT.—

4 (1) IN GENERAL.—Chapter 80 of title 10,
5 United States Code, is amended by adding at the
6 end the following new section:

7 **“§ 1568. Training program on antisemitism**

8 “(a) IN GENERAL.—The Secretary of the Defense
9 shall establish a mandatory training program for all per-
10 sonnel of the Department of Defense to—

11 “(1) promote recognition and prevention of
12 antisemitism and far-right extremism within the De-
13 partment;

14 “(2) educate such personnel on the history,
15 forms, and manifestations of antisemitism;

16 “(3) provide guidance on identifying antisemitic
17 incidents and language;

18 “(4) establish clear reporting mechanisms and
19 protections against retaliation; and

1 “(5) emphasize the impact of antisemitism on
2 military readiness, morale, and cohesion.

3 “(d) SUNSET.—The requirement to provide training
4 under this section shall terminate on December 31, 2033.

5 “(e) DEFINITIONS.—In this section:

6 “(1) The term ‘antisemitism’—

7 “(A) means the working definition of anti-
8 semitism adopted by the International Holo-
9 caust Remembrance Alliance on May 26, 2016;
10 and

11 “(B) includes the contemporary examples
12 of antisemitism described in the explanation ac-
13 companying such working definition.

14 “(2) The term ‘far-right extremism’ means a
15 movement or ideology that—

16 “(A) supports white supremacist or
17 ethnonationalist beliefs;

18 “(B) advocates for an authoritarian or
19 ultranationalist government, as well as the use
20 of violence to achieve political objectives;

21 “(C) rejects democratic institutions and
22 pluralistic society;

23 “(D) promotes conspiratorial ideologies
24 often including antisemitic, xenophobic, or anti-
25 democratic narratives;”.

1 (2) DEADLINE.—The Secretary of Defense shall
2 establish the training program required under sec-
3 tion 1568 of title 10, United States Code, as added
4 by subsection (a) of this section, not later than 180
5 days after the date of the enactment of this Act.

6 (b) REPORT.—Not later than 2 years after the date
7 of the enactment of this Act, the Secretary of Defense
8 shall submit to the Committees on Armed Services of the
9 Senate and the House of Representatives a report that
10 includes—

11 (1) a detailed description of the antisemitism
12 training program established under section 1568 of
13 title 10, United States Code, as added by subsection
14 (a) of this section, including—

15 (A) training content and learning objec-
16 tives; and

17 (B) delivery methods and platforms used;

18 (2) the total number and percentage of per-
19 sonnel who have completed the required training,
20 disaggregated by—

21 (A) civilian personnel and members of the
22 Armed Forces; and

23 (B) with respect to members of the Armed
24 Forces, Armed Force and pay grade;

1 (3) a list of consultants, organizations, or exter-
2 nal entities involved in the development or delivery
3 of the training; and

4 (4) an assessment of initial feedback from par-
5 ticipants and trainers, including pre- and post-train-
6 ing evaluations where available.

7 (c) BRIEFING.—Not later than July 1, 2026, the Sec-
8 retary shall brief the Committees on Armed Services of
9 the Senate and House of Representatives on implementa-
10 tion of this section and plans regarding continuing anti-
11 semitism training under section 1568 of title 10, United
12 States Code, as added by subsection (a) of this section.
