

AMENDMENT TO RULES COMMITTEE PRINT 118-

OFFERED BY MR. TONY GONZALES OF TEXAS

At the end of subtitle C of title XXVIII, add the following new section:

1 **SEC. 28___. UPDATE TO ASSESSMENT ON SCHOOL CAPAC-**
2 **ITY AND CONDITION.**

3 (a) REPORT REQUIRED.—

4 (1) UPDATE.—Not later than one year after the
5 date of the enactment of this Act, the Secretary of
6 Defense shall submit to the congressional defense
7 committees an update of the assessment on the ca-
8 pacity and facility condition deficiencies of elemen-
9 tary and secondary public schools on military instal-
10 lations conducted by the Secretary in July 2017
11 under section 2814 of National Defense Authoriza-
12 tion Act for Fiscal Year 2017 (Public Law 114–328;
13 130 Stat. 2717). In updating the assessment, the
14 Secretary shall take into consideration factors in-
15 cluding—

16 (A) schools that have had changes in their
17 condition or capacity since the most recent as-
18 sessment; and

1 (B) the capacity and facility condition defi-
2 ciencies of schools omitted from the most recent
3 assessment.

4 (2) ADDITIONAL INFORMATION.—The Secretary
5 shall include in the update submitted under para-
6 graph (1) a report on the status of the funds already
7 appropriated, and the schedule for completion of
8 projects already approved, under the programs fund-
9 ed Under section 8127 of the Consolidated Appro-
10 priations Act, 2018 (Public Law 115-141; 132 Stat.
11 492), section 8128 of the Department of Defense
12 and Labor, Health and Human Services, and Edu-
13 cation Appropriations Act, 2019 and Continuing Ap-
14 propriations Act, 2019 (Public Law 115-245; 123
15 Stat. 3029), section 8121 of the Consolidated Ap-
16 propriations Act, 2020 (Public Law 116-93; 133
17 Stat. 2365), section 8118 of the Consolidated Ap-
18 propriations Act, 2021 (Public Law 116-260; 134
19 Stat. 1332), and section 8109 of the Consolidated
20 Appropriations Act, 2022 (Public Law 117-103; 136
21 Stat. 201).

22 (b) COMPTROLLER GENERAL EVALUATION.—Not
23 later than 180 days after the date of submission of the
24 report under subsection (a), the Comptroller General of
25 the United States shall submit to the congressional de-

- 2 prepared by the Secretary of Defense under subsection
- 3 (a)(1), including an evaluation of the accuracy and analyt-
- 4 ical sufficiency of the updated assessment.
