## OFFERED BY MR. TONY GONZALES OF TEXAS

At the end of subtitle A of title XVII, insert the following new section:

- 1 SEC. 17 . NATIONAL DIGITAL RESERVE CORPS.
- 2 (a) In General.—Subpart I of part III of title 5,
- 3 United States Code, is amended by adding at the end the
- 4 following new chapter:
- 5 **"CHAPTER 104—NATIONAL DIGITAL**
- 6 **RESERVE CORPS**

## 7 **"§ 10401. Definitions**

- 8 "In this chapter:
- 9 "(1) Active reservist.—The term 'active re-
- servist' means a reservist holding a position to which
- such reservist has been appointed under section
- 12 10403(c)(2).

1	"(2) Administrator.—The term 'Adminis-
2	trator' means the Administrator of the General
3	Services Administration.
4	"(3) COVERED EXECUTIVE AGENCY.—The term
5	'covered Executive agency' means an Executive
6	agency as defined in section 105, except that such
7	term includes the United States Postal Service, the
8	Postal Regulatory Commission, and the Executive
9	Office of the President.
10	"(4) Program.—The term 'Program' means
11	the program established under section 10402(a).
12	"(5) Reservist.—The term 'reservist' means
13	an individual who is a member of the National Dig-
14	ital Reserve Corps.
15	"§ 10402. Establishment
16	"(a) Establishment.—There is established in the
17	General Services Administration a program to establish,
18	recruit, manage, and assign a reserve of individuals with
19	relevant skills and credentials, to be known as the 'Na-
20	tional Digital Reserve Corps', to help address the digital
21	and cybersecurity needs of covered Executive agencies.
22	"(b) Implementation.—
23	"(1) Guidance.—Not later than six months
24	after the date of the enactment of this section, the
25	Administrator, in consultation with the Director of

1	the Office of Personnel Management, shall issue
2	guidance for the National Digital Reserve Corps,
3	which shall include procedures for coordinating with
4	covered Executive agencies to—
5	"(A) identify digital and cybersecurity
6	needs which may be addressed by the National
7	Digital Reserve Corps; and
8	"(B) assign active reservists to address
9	such needs.
10	"(2) Recruitment and initial assign-
11	MENTS.—Not later than one year after the date of
12	the enactment of this section, the Administrator
13	shall begin recruiting reservists and assigning active
14	reservists under the Program.
15	"§ 10403. Organization
16	"(a) Administration.—
17	"(1) In General.—The National Digital Re-
18	serve Corps shall be administered by the Adminis-
19	trator.
20	"(2) Responsibilities.—In carrying out the
21	Program, the Administrator shall—
22	"(A) establish standards for serving as a
23	reservist, including educational attainment, pro-
24	fessional qualifications, and background checks
25	in accordance with existing Federal guidance;

1	"(B) ensure the standards established
2	under subparagraph (A) are met;
3	"(C) recruit individuals to the National
4	Digital Reserve Corps;
5	"(D) activate and deactivate reservists as
6	necessary;
7	"(E) coordinate with covered Executive
8	agencies to—
9	"(i) determine the digital and cyberse-
10	curity needs which reservists shall be as-
11	signed to address;
12	"(ii) ensure active reservists have ac-
13	cess, resources, and equipment required to
14	address digital and cybersecurity needs
15	which such reservists are assigned to ad-
16	dress; and
17	"(iii) analyze potential assignments
18	for reservists to determine outcomes, de-
19	velop anticipated assignment timelines, and
20	identify covered Executive agency partners;
21	"(F) ensure reservists acquire and main-
22	tain appropriate security clearances; and
23	"(G) determine what additional resources,
24	if any, are required to successfully implement
25	the Program.

1	"(b) National Digital Reserve Corps Partici-
2	PATION.—
3	"(1) Service obligation agreement.—
4	"(A) IN GENERAL.—An individual may be-
5	come a reservist only if such individual enters
6	into a written agreement with the Adminis-
7	trator to become a reservist.
8	"(B) Contests.—The agreement under
9	subparagraph (A) shall—
10	"(i) require the individual seeking to
11	become a reservist to serve as a reservist
12	for a 3-year period, during which such in-
13	dividual shall serve not less than 30 days
14	per year as an active reservist; and
15	"(ii) set forth all other the rights and
16	obligations of the individual and the Gen-
17	eral Services Administration.
18	"(2) Compensation.—The Administrator shall
19	determine the appropriate compensation for service
20	as a reservist, except that the annual pay for such
21	service shall not exceed \$10,000.
22	"(3) Employment protections.—The Sec-
23	retary of Labor shall prescribe such regulations as
24	necessary to ensure the reemployment, continuation
25	of benefits, and nondiscrimination in reemployment

1	of active reservists, provided that such regulations
2	shall include, at a minimum, those rights and obliga-
3	tions set forth under chapter 43 of title 38.
4	"(4) Penalties.—
5	"(A) IN GENERAL.—A reservist that fails
6	to accept an appointment under subsection
7	(c)(2) or fails to carry out the duties assigned
8	to a reservist under such an appointment shall,
9	after notice and an opportunity to be heard—
10	"(i) cease to be a reservist; and
11	"(ii) be fined an amount equal to the
12	sum of—
13	"(I) an amount equal to the
14	amounts, if any, paid under section
15	10405 with respect to such reservist;
16	and
17	"(II) the difference between the
18	amount of compensation such reserv-
19	ist would have received if the reservist
20	completed the entire term of service
21	as a reservist agreed to in the agree-
22	ment described in paragraph (1) and
23	the amount of compensation such re-
24	servist has received under such agree-
25	ment.

1	"(B) Exception.—
2	"(i) In General.—Subparagraph (A)
3	shall not apply with respect to a failure of
4	a reservist to accept an appointment under
5	subsection (c)(2) or to carry out the duties
6	assigned to the reservist under such an ap-
7	pointment if—
8	"(I) the failure was due to the
9	death or disability of such reservist; or
10	"(II) the Administrator, in con-
11	sultation with the head of the relevant
12	covered Executive agency, determines
13	that subparagraph (A) should not
14	apply with respect to the failure.
15	"(ii) Relevant covered executive
16	AGENCY DEFINED.—In this subparagraph,
17	the term 'relevant covered Executive agen-
18	cy' means—
19	"(I) in the case of a reservist
20	failing to accept an appointment
21	under subsection $(c)(2)$ , the covered
22	Executive agency to which such re-
23	servist would have been appointed;
24	and

1	"(II) in the case of a reservist
2	failing to carry out the duties as-
3	signed to such reservist under such an
4	appointment, the covered Executive
5	agency to which such reservist was
6	appointed.
7	"(c) HIRING AUTHORITY.—
8	"(1) Corps leadership.—The Administrator
9	may appoint qualified candidates to positions in the
10	competitive service in the General Service Adminis-
11	tration for which the primary duties are related to
12	the management or administration of the National
13	Digital Reserve Corps, as determined by the Admin-
14	istrator.
15	"(2) Corps reservists.—
16	"(A) IN GENERAL.—The Administrator
17	may appoint qualified reservists to temporary
18	positions in the competitive service for the pur-
19	pose of assigning such reservists under section
20	10404 and to otherwise carry out the National
21	Digital Reserve Corps.
22	"(B) Appointment limits.—
23	"(i) IN GENERAL.—The Administrator
24	may not appoint an individual under this
25	paragraph if during the 365-day period

1	ending on the date of such appointment,
2	such individual has been an officer or em-
3	ployee of the executive or legislative branch
4	of the United States Government, of any
5	independent agency of the United States,
6	or of the District of Columbia for not less
7	than 130 days.
8	"(ii) Automatic appointment ter-
9	MINATION.—The appointment of an indi-
10	vidual under this paragraph shall termi-
11	nate upon such individual being employed
12	as an officer or employee of the executive
13	or legislative branch of the United States
14	Government, of any independent agency of
15	the United States, or of the District of Co-
16	lumbia for 130 days during the previous
17	365 days.
18	"(C) Employee status.—An individual
19	appointed under this paragraph shall be consid-
20	ered a special Government employee (as such
21	term is defined in section 202(a) of title 18).
22	"(D) Conflict of interest.—Individ-
23	uals appointed under this section shall not, as
24	an active reservist, have access to proprietary or
25	confidential information that is of commercial

1	value to any private entity or individual employ-
2	ing such appointee.
3	"(E) Additional employees.—Individ-
4	uals appointed under this paragraph shall be in
5	addition to any employees of the General Serv-
6	ices Administration whose duties relate to the
7	digital or cybersecurity needs of the General
8	Services Administration.
9	"§ 10404. Assignments
10	"(a) In General.—The Administrator may assign
11	active reservists to address the digital and cybersecurity
12	needs of covered Executive agencies, including cybersecu-
13	rity services, digital education and training, data triage,
14	acquisition assistance, guidance on digital projects, devel-
15	opment of technical solutions, and bridging public needs
16	and private sector capabilities.
17	"(b) Assignment-specific Access, Resources,
18	SUPPLIES, OR EQUIPMENT.—The head of a covered Exec-
19	utive agency shall, to the extent practicable, provide each
20	active reservist assigned to address a digital or cybersecu-
21	rity need of such covered Executive agency under sub-
22	section (a) with any specialized access, resources, supplies,
23	or equipment required to address such digital or cyberse-
24	curity need.

1	"(c) Duration.—An assignment of an individual
2	under subsection (a) shall terminate on the earlier of—
3	"(1) the date determined by the Administrator;
4	"(2) the date on which the Administrator re-
5	ceives notification of the decision of the head of the
6	covered Executive agency, the digital or cybersecu-
7	rity needs of which such individual is assigned to ad-
8	dress under subsection (a), that such assignment
9	should terminate; or
10	"(3) the date on which the assigned individual
11	ceases to be an active reservist.
12	"§ 10405. Reservist continuing education
13	"(a) In General.—Subject to the availability of ap-
14	propriations, the Administrator may pay for reservists to
15	acquire training and receive continuing education related
16	to the duties assigned to such reservists pursuant to ap-
17	pointments under section $10403(c)(2)$ , including attending
18	conferences and seminars and obtaining certifications,
19	that will enable reservists to more effectively meet the dig-
20	ital and cybersecurity needs of covered Executive agencies.
21	"(b) APPLICATION.—The Administrator shall estab-
22	lish a process for reservists to apply for the payment of
23	reasonable expenses related to the training or continuing
24	education described in subsection (a).

1	"(c) Report.—Not later than one year after the date
2	of the enactment of this section, and annually thereafter,
3	the Administrator shall submit to Congress a report on
4	the expenditures under this subsection.
5	"§ 10406. Congressional reports
6	"Not later than two years after the date of the enact-
7	ment of this section, and annually thereafter, the Adminis-
8	trator shall submit to Congress a report on the Program,
9	including—
10	"(1) the number of reservists;
11	"(2) a list of covered Executive agencies that
12	have submitted requests for support from the Na-
13	tional Digital Reserve Corps;
14	"(3) the nature and status of such requests;
15	and
16	"(4) with respect to each such request to which
17	active reservists have been assigned and for which
18	work by the National Digital Reserve Corps has con-
19	cluded, an evaluation of such work and the results
20	of such work by—
21	"(A) the covered Executive agency that
22	submitted the request; and
23	"(B) the reservists assigned to such re-
24	quest.

## 1 **"§ 10407. Construction**

- 2 "Nothing in this chapter shall be construed to abro-
- 3 gate or otherwise affect the authorities or the responsibil-
- 4 ities of the head of any other Executive agency.".
- 5 (b) CLERICAL AMENDMENT.—The table of chapters
- 6 for part III of title 5, United States Code, is amended
- 7 by inserting after the item related to chapter 103 the fol-
- 8 lowing new item:

- 9 (c) AUTHORIZATION OF APPROPRIATIONS.—There is
- 10 authorized to be appropriated \$30,000,000, to remain
- 11 available until fiscal year 2026 to carry out the program
- 12 established under section 10402(a) of title 5, United
- 13 States Code, as added by this section.
- 14 (d) Transition Assistance Program.—Section
- 15 1142(b)(3) of title 10, United States Code, is amended
- 16 by inserting "and the National Digital Reserve Corps"
- 17 after "Selected Reserve".
- 18 (e) Offset.—Notwithstanding the amounts set forth
- 19 in the funding tables in division D, the amounts author-
- 20 ized to be appropriated in section 301 for operation and
- 21 maintenance, Defense-wide, for administration and serv-
- 22 ice-wide activities, Office of the Secretary of Defense, Line

- 1 470, as specified in the corresponding funding table in sec-
- 2 tion 4301, is hereby reduced by \$30,000,000.
