

AMENDMENT TO RULES COMM. PRINT 119–33
OFFERED BY MR. GOTTHEIMER OF NEW JERSEY

At the end of title XVII of division A, add the following:

1 **Subtitle C—Polisario Front**
2 **Terrorist Designation Act of 2026**

3 **SEC. 17__. SHORT TITLE.**

4 This subtitle may be cited as the “Polisario Front
5 Terrorist Designation Act of 2026”.

6 **SEC. 17__. DEFINITIONS.**

7 In this subtitle:

8 (1) IRANIAN-AFFILIATED TERRORIST ORGANIZA-
9 TION.—The term “Iranian-affiliated terrorist organi-
10 zation” means an Iranian entity that has been des-
11 ignated as—

12 (A) a foreign terrorist organization pursu-
13 ant to section 219(a) of the Immigration and
14 Nationality Act (8 U.S.C. 1189(a)); or

15 (B) a Specially Designated Global Ter-
16 rorist pursuant to Executive Order 13224 (50
17 U.S.C. 1701 note; relating to blocking property
18 and prohibiting transactions with persons who

1 commit, threaten to commit, or support ter-
2 rorism).

3 (2) IRANIAN ENTITY.—The term “Iranian enti-
4 ty” means any entity that is—

5 (A) an Iranian person (as defined in sec-
6 tion 6(f) of the Fight CRIME Act (division K
7 of Public Law 118–50)); or

8 (B) Hezbollah.

9 (3) POLISARIO FRONT.—The term “Polisario
10 Front” means the Popular Front for the Liberation
11 of Saguia el-Hamra and Río de Oro, which was
12 founded on May 10, 1973, or any successor organi-
13 zation.

14 (4) RELEVANT CONGRESSIONAL COMMIT-
15 TEES.—The term “relevant congressional commit-
16 tees” means—

17 (A) the Committee on Foreign Relations of
18 the Senate; and

19 (B) the Committee on Foreign Affairs of
20 the House of Representatives.

21 **SEC. 17 . ANNUAL REPORT.**

22 (a) IN GENERAL.—Not later than 90 days after the
23 date of the enactment of this Act, and annually thereafter,
24 the Secretary of State shall submit a report to the relevant
25 congressional committees on cooperation between the

1 Polisario Front and Iranian-affiliated terrorist organiza-
2 tions during the period specified in subsection (c).

3 (b) REQUIRED ELEMENTS.—Each report required
4 under subsection (a) shall include a determination of
5 whether, during the period specified in subsection (c), the
6 Polisario Front provided or received from an Iranian-af-
7 filiated terrorist organization, including through inter-
8 mediary parties—

9 (1) armed support in military operations;

10 (2) weapons systems, including man-portable,
11 individual use firearms;

12 (3) unmanned aerial vehicles, including com-
13 mercially available component parts to such vehicles;

14 (4) systems, platforms, or components designed
15 to detect, track engage, or destroy airborne targets;

16 or

17 (5) military intelligence, including surveillance
18 data, targeting information, signal or human intel-
19 ligence, and any analysis derived from such sources,
20 whether provided in raw or processed form.

21 (c) PERIOD.—The period specified in this subsection
22 is—

23 (1) with respect to the first report submitted
24 pursuant to subsection (a), the period beginning 10
25 years before the date of the enactment of this Act

1 and ending on the date on which such report is sub-
2 mitted; and

3 (2) with respect to each subsequent report, the
4 period beginning on the date on which the previous
5 report was submitted and the date on which the new
6 report is submitted.

7 (d) FORM.—The determination required under sub-
8 section (b) in the report required under subsection (a)
9 shall be submitted in unclassified form.

10 **SEC. 17__ . SANCTIONS.**

11 (a) IN GENERAL.—Not later than 30 days after the
12 submission of each report required under section 17__, in
13 the case of a positive determination made pursuant to the
14 determination required under subsection 17__(b), the
15 President shall impose the sanctions described in sub-
16 section (b).

17 (b) SANCTIONS DESCRIBED.—The sanctions de-
18 scribed in this subsection are—

19 (1) designation as a foreign terrorist organiza-
20 tion pursuant to section 219(a) of the Immigration
21 and Nationality Act (8 U.S.C. 1189(a)); and

22 (2) imposition of the sanctions applicable with
23 respect to a foreign person pursuant to Executive
24 Order 13224 (50 U.S.C. 1701 note; relating to
25 blocking property and prohibiting transactions with

1 persons who commit, threaten to commit, or support
2 terrorism).
