Page 5, after line 4, insert the following:

## SEC. 4. CURRICULUM FOR THE STUDY OF ANTISEMITISM SURROUNDING AND LEADING UP TO HAMAS' OCTOBER 7, 2023, TERRORIST ATTACKS AGAINST ISRAEL.

5 (a) CURRICULUM DEVELOPMENT.—Beginning not 6 later than 180 days after the date of the enactment of 7 this Act, the Director of the United States Holocaust Memorial Museum (referred to in this section as the "Direc-8 9 tor") shall develop a curriculum for the study of Hamas' October 7, 2023, terrorist attacks against Israel, for use 10 11 in secondary schools. Such curriculum shall include information on-12

- 13 (1) the heinous and brutal attacks committed14 against Israel by Hamas on October 7, 2023;
- 15 (2) the history of antisemitism and how it16 played a role in such attacks;

17 (3) how antisemitism and anti-Israel rhetoric
18 spread throughout the United States and on cam19 puses of institutions of higher education following
20 such attacks;

1	(4) how social media accelerated the spread of
2	antisemitism and anti-Israel rhetoric following such
3	attacks; and
4	(5) denial and distortion as a form of anti-
5	semitism in the wake of such attacks.
6	(b) Report.—
7	(1) IN GENERAL.—Following the completion of
8	the curriculum development under subsection (a),
9	the Director shall prepare and submit to Congress a
10	report on the curriculum described in subsection (a).
11	(2) DEADLINE FOR SUBMISSION.—The report
12	under paragraph (1) shall be submitted not later
13	than the earlier of—
14	(A) 180 days after the completion of the
15	curriculum development under subsection (a);
16	or
17	(B) 3 years after the date of the enact-
18	ment of this section.
19	(c) DEFINITIONS.—In this section:
20	(1) ANTISEMITISM.—The term "antisemitism"
21	has the meaning given the working definition of
22	antisemitism adopted by the International Holocaust
23	Remembrance Alliance on May 26, 2016, including
24	the contemporary examples of antisemitism cited by
25	the Alliance.

1 (2) HAMAS' OCTOBER 7, 2023, TERRORIST AT-2 TACKS AGAINST ISRAEL.—The term "Hamas' Octo-3 ber 7, 2023, terrorist attacks against Israel" refers to the surprise land, sea, and air attacks against 4 5 Israel led by the Palestinian Sunni Islamist group 6 Hamas (a United States-designated foreign terrorist 7 organization) from the Gaza Strip on October 7, 8 2023 (the Jewish holiday Simchat Torah and 50 9 years after the 1973 Yom Kippur War), in which 10 Hamas brutally murdered, decapitated, burned alive, 11 and raped over 1,200 men, women, children, and el-12 derly, and kidnapped over 240 people, including 13 Americans.
