**OFFERED BY MR. GRAVES OF LOUISIANA**

Add at the end of title XII the following new section:

1 **SEC. 120007. MAJOR MEDICAL FACILITY LEASES OF THE**  
2 **DEPARTMENT OF VETERANS AFFAIRS.**

3 (a) IN GENERAL.—The Secretary of Veterans Affairs  
4 may carry out the following major medical facility leases  
5 at the locations specified and in an amount not to exceed  
6 the amount shown for such location (not including any es-  
7 timated cancellation costs):

8 (1) For a replacement administrative lease, At-  
9 lanta, Georgia, an amount not to exceed  
10 \$14,146,000.

11 (2) For a replacement outpatient clinic, Balti-  
12 more, Maryland, an amount not to exceed  
13 \$26,005,000.

14 (3) For a replacement outpatient clinic, Baton  
15 Rouge, Louisiana, an amount not to exceed  
16 \$18,923,000.

17 (4) For a replacement outpatient clinic, Beau-  
18 fort, South Carolina, an amount not to exceed  
19 \$12,677,000.

1           (5) For a replacement outpatient clinic, Beau-  
2           mont, Texas, an amount not to exceed \$9,851,000.

3           (6) For a new research lab, Columbia, Missouri,  
4           an amount not to exceed \$14,889,000.

5           (7) For a replacement outpatient clinic, Hamp-  
6           ton, Virginia, an amount not to exceed \$45,958,000.

7           (8) For a replacement outpatient clinic, Jack-  
8           sonville, North Carolina, an amount not to exceed  
9           \$31,334,000.

10          (9) For a replacement outpatient clinic, Law-  
11          rence, Indiana, an amount not to exceed \$9,126,000.

12          (10) For a replacement outpatient clinic, Nash-  
13          ville, Tennessee, an amount not to exceed  
14          \$34,205,000.

15          (11) For a replacement outpatient clinic, Plano,  
16          Texas, an amount not to exceed \$21,172,000.

17          (12) For a replacement outpatient clinic, Prince  
18          George's County, Maryland, an amount not to ex-  
19          ceed \$18,159,000.

20          (13) For a replacement outpatient clinic, Salt  
21          Lake City, Utah, an amount not to exceed  
22          \$18,485,000.

23          (b) AUTHORIZATION OF APPROPRIATIONS FOR MED-  
24          ICAL FACILITY LEASES.—There is authorized to be appro-  
25          priated to the Secretary of Veterans Affairs for fiscal year

- 1 2021, or the year in which funds are appropriated for the
- 2 Medical Facilities account, \$274,920,000 for the major
- 3 medical facility leases authorized under subsection (a).
