4 (a) REPEAL OF GOVERNMENT PENSION OFFSET
5 PROVISION.—

6 (1) IN GENERAL.—Section 202(k) of the Social
7 Security Act (42 U.S.C. 402(k)) is amended by
8 striking paragraph (5).

9 (2) CONFORMING AMENDMENTS.—

10 (A) Section 202(b)(2) of the Social Secu-
11 rity Act (42 U.S.C. 402(b)(2)) is amended by
12 striking “subsections (k)(5) and (q)” and in-
13 sserting “subsection (q)”.

14 (B) Section 202(c)(2) of such Act (42
15 U.S.C. 402(c)(2)) is amended by striking “sub-
16 sections (k)(5) and (q)” and inserting “sub-
17 section (q)”.

18 (C) Section 202(e)(2)(A) of such Act (42
19 U.S.C. 402(e)(2)(A)) is amended by striking

1 “subsection (k)(5), subsection (q),” and insert-
2 ing “subsection (q)”.

3 (D) Section 202(f)(2)(A) of such Act (42
4 U.S.C. 402(f)(2)(A)) is amended by striking
5 “subsection (k)(5), subsection (q)” and insert-
6 ing “subsection (q)”.

7 (b) REPEAL OF WINDFALL ELIMINATION PROVI-
8 SIONS.—

9 (1) IN GENERAL.—Section 215 of the Social
10 Security Act (42 U.S.C. 415) is amended—

11 (A) in subsection (a), by striking para-
12 graph (7);

13 (B) in subsection (d), by striking para-
14 graph (3); and

15 (C) in subsection (f), by striking para-
16 graph (9).

17 (2) CONFORMING AMENDMENTS.—Subsections
18 (e)(2) and (f)(2) of section 202 of such Act (42
19 U.S.C. 402) are each amended by striking “section
20 215(f)(5), 215(f)(6), or 215(f)(9)(B)” in subpara-
21 graphs (C) and (D)(i) and inserting “paragraph (5)
22 or (6) of section 215(f)”.

23 (c) EFFECTIVE DATE.— The amendments made by
24 this section shall apply with respect to monthly insurance
25 benefits payable under title II of the Social Security Act

1 for months after December 2019. Notwithstanding section
2 215(f) of the Social Security Act, the Commissioner of So-
3 cial Security shall adjust primary insurance amounts to
4 the extent necessary to take into account the amendments
5 made by section 3.
