## OFFERED BY MR. GRAVES OF LOUISIANA

At the end of subtitle F of title VIII, insert the following:

## 1 SEC. 8\_\_\_\_\_. INDIVIDUAL ACQUISITION FOR COMMERCIAL 2 LEASING SERVICES.

3 (a) IN GENERAL.—For the purpose of section 863 4 of Public Law 110–417, an individual acquisition for com-5 mercial leasing services shall not be construed as a pur-6 chase of property or services if such individual acquisition 7 is made on a no cost basis and pursuant to a multiple 8 award contract awarded in accordance with requirements 9 for full and open competition.

10 (b) AUDIT.—The Comptroller General of the United11 States shall—

- (1) conduct biennial audits of the General Services Administration National Broker Contract to determine—
- 15 (A) whether brokers selected under the
  16 program provide lower lease rental rates than
  17 rates negotiated by General Services Adminis18 tration staff; and

1	(B) the impact of the program on the
2	length of time of lease procurements;
3	(2) conduct a review of whether the application
4	of section 863 of Public Law 110–417 to acquisi-
5	tions for commercial leasing services resulted in
6	rental cost savings for the Government during the
7	years in which such section was applicable prior to
8	the date of enactment of this section; and
9	(3) not later than September 30, 2019, and
10	September 30, 2021, submit to the Committee on
11	Transportation and Infrastructure of the House of
12	Representatives and the Committee on Environment
13	and Public Works of the Senate a report that—
14	(A) summarizes the results of the audit
15	and review required by paragraphs $(1)$ and $(2)$ ;
16	(B) includes an assessment of whether the
17	National Broker Contract provides greater effi-
18	ciencies and savings than the use of General
19	Services Administration staff; and
20	(C) includes recommendations for improv-
21	ing General Services Administration lease pro-
22	curements.
23	(c) TERMINATION.—This section shall terminate on
24	December 31, 2022.
