(c) EFFECTIVE DATE.—The amendments made by 1 this section shall apply with respect to monthly insurance 2 3 benefits payable under title II of the Social Security Act for months after September 2018. Notwithstanding sec-4 tion 215(f) of the Social Security Act, the Commissioner 5 of Social Security shall adjust primary insurance amounts 6 7 to the extent necessary to take into account the amendments made by this section. 8
