At the end of title XIII, add the following:

1 **Subtitle I—Social Security Fairness**
2 **Act**

3 **SEC. 131101. REPEAL OF GOVERNMENT PENSION OFFSET**
4 **PROVISION.**

5 (a) IN GENERAL.—Section 202(k) of the Social Secu-
6 rity Act (42 U.S.C. 402(k)) is amended by striking para-
7 graph (5).

8 (b) CONFORMING AMENDMENTS.—

9 (1) Section 202(b)(2) of the Social Security Act
10 (42 U.S.C. 402(b)(2)) is amended by striking “sub-
11 sections (k)(5) and (q)” and inserting “subsection
12 (q)”.

13 (2) Section 202(c)(2) of such Act (42 U.S.C.
14 402(c)(2)) is amended by striking “subsections
15 (k)(5) and (q)” and inserting “subsection (q)”.

16 (3) Section 202(e)(2)(A) of such Act (42
17 U.S.C. 402(e)(2)(A)) is amended by striking “sub-
18 section (k)(5), subsection (q),” and inserting “sub-
19 section (q)”.

1 (4) Section 202(f)(2)(A) of such Act (42 U.S.C.
2 402(f)(2)(A)) is amended by striking “subsection
3 (k)(5), subsection (q)” and inserting “subsection
4 (q)”.

5 **SEC. 131102. REPEAL OF WINDFALL ELIMINATION PROVI-**
6 **SIONS.**

7 (a) IN GENERAL.—Section 215 of the Social Security
8 Act (42 U.S.C. 415) is amended—

9 (1) in subsection (a), by striking paragraph (7);

10 (2) in subsection (d), by striking paragraph (3);

11 and

12 (3) in subsection (f), by striking paragraph (9).

13 (b) CONFORMING AMENDMENTS.—Subsections (e)(2)
14 and (f)(2) of section 202 of such Act (42 U.S.C. 402) are
15 each amended by striking “section 215(f)(5), 215(f)(6),
16 or 215(f)(9)(B)” in subparagraphs (C) and (D)(i) and in-
17 serting “paragraph (5) or (6) of section 215(f)”.

18 **SEC. 131103. EFFECTIVE DATE.**

19 The amendments made by this subtitle shall apply
20 with respect to monthly insurance benefits payable under
21 title II of the Social Security Act for months after Decem-
22 ber 2021. Notwithstanding section 215(f) of the Social Se-
23 curity Act, the Commissioner of Social Security shall ad-
24 just primary insurance amounts to the extent necessary

1 to take into account the amendments made by section
2 9902.
