

**AMENDMENT TO**  
**RULES COMMITTEE PRINT 116-57**  
**OFFERED BY MR. GRAVES OF LOUISIANA**

At the end of subtitle E of title XVII, add the following new section:

1 **SEC. 17\_\_\_ . AUTHORIZATION OF MAJOR MEDICAL FACILITY**  
2 **LEASES.**

3 The Secretary of Veterans Affairs may carry out the  
4 following major medical facility leases at the locations  
5 specified, and in an amount for each lease not to exceed  
6 the amount shown for such location (not including any es-  
7 timated cancellation costs):

8 (1) For a replacement administrative lease for  
9 VHA Member Services in Atlanta, Georgia, an  
10 amount not to exceed \$14,146,000.

11 (2) For a replacement Outpatient Clinic in Bal-  
12 timore, Maryland, an amount not to exceed  
13 \$26,005,000.

14 (3) For a replacement Outpatient Clinic in  
15 Baton Rouge, Louisiana, in an amount not to exceed  
16 \$18,923,000.

1           (4) For a replacement Outpatient Clinic in  
2           Beaufort, South Carolina, in an amount not to ex-  
3           ceed \$12,667,000.

4           (5) For a replacement Outpatient Clinic in  
5           Beaumont, Texas, in support of the Michael E.  
6           DeBakey VA Medical Center in Houston, Texas, in  
7           an amount not to exceed \$9,851,000

8           (6) For a research lab space in support of the  
9           Harry S. Truman Memorial Veterans' Hospital in  
10          Columbia, Missouri, in an amount not to exceed  
11          \$14,889,000.

12          (7) For a new Outpatient Clinic in Hampton  
13          Roads, Virginia, in an amount not to exceed  
14          \$45,958,000.

15          (8) For a replacement Outpatient Clinic in  
16          Jacksonville, North Carolina, in an amount not to  
17          exceed \$31,334,000.

18          (9) For a new Outpatient Clinic in Lawrence,  
19          Indiana to support the Richard L. Roudebush VA  
20          Medical Center in Indianapolis, Indiana, in an  
21          amount not to exceed \$9,126,000.

22          (10) For a replacement Outpatient Clinic in  
23          Nashville, Tennessee, in an amount not to exceed  
24          \$34,205,000.

1           (11) For a replacement Outpatient Clinic in  
2           Plano, Texas in support of the VA North Texas  
3           Health Care System in Dallas, Texas, in an amount  
4           not to exceed \$21,172,000

5           (12) For a replacement Outpatient Clinic in  
6           Prince Georges County, Maryland, in support of the  
7           Veterans Affairs Medical Center in Washington, DC,  
8           in an amount not to exceed \$18,159,000.

9           (13) For a new Outpatient Clinic in Salt Lake  
10          City, Utah, in support of the Veterans Health Care  
11          System in Salt Lake City, Utah, in an amount not  
12          to exceed \$18,485,000.
