3	(1) In general.—The State shall make sub-
4	grants to local educational agencies under subsection
5	(a)(1)(A) as follows:
6	(A) One-third of funds shall be awarded
7	not less than 15 calendar days after receiving
8	an award from the Secretary under this section.
9	(B) The remaining two-thirds of funds
10	shall be awarded only after the local educational
11	agency submits to the Governor and the Gov-
12	ernor approves a comprehensive school reopen-
13	ing plan with respect to the remainder of school
14	year 2020-2021 based on criteria determined by
15	the Governor in consultation with the State
16	educational agency (including criteria for the

1	Governor to carry out paragraph (2)), that de-
2	scribes how the local educational agency will
3	safely reopen schools with the physical presence
4	of students, consistent with maintaining safe
5	and continuous operations aligned with chal-
6	lenging State academic standards.
7	(2) APPROVAL OF PLANS.—The Governor shall
8	approve plans submitted under paragraph (1)(B)
9	within 30 days after the plan is submitted, subject
10	to the following requirements:
11	(A) A local educational agency that pro-
12	vides in-person instruction for at least 50 per-
13	cent of its students where the students phys-
14	ically attend school no less than 50 percent of
15	each school-week, as it was defined by the local
16	educational agency prior to the coronavirus
17	emergency, shall have its plan automatically ap-
18	proved.
19	(B) A local educational agency that does
20	not provide in-person instruction to any stu-
21	dents where the students physically attend
22	school in-person shall not be eligible to receive
23	a subgrant under paragraph (1)(B).
24	(C) A local educational agency that pro-
25	vides in-person instruction to at least some stu-

1	dents where the students physically attend
2	school in-person but does not satisfy the re-
3	quirements in subparagraph (A) shall have its
4	allocation reduced on a pro rata basis as deter-
5	mined by the Governor.
6	(3) Plan contents.—A school reopening plan
7	submitted to a Governor under paragraph (1)(B)
8	shall include, in addition to any other information
9	necessary to meet the criteria determined by the
10	Governor—
11	(A) a detailed timeline for when the local
12	educational agency will provide in-person in-
13	struction, including the goals and criteria used
14	for providing full time in-person instruction to
15	all students;
16	(B) a description of how many days of in-
17	person instruction per calendar week the local
18	educational agency plans to offer to students;
19	and
20	(C) an assurance that the local educational
21	agency will offer students as much in-person in-
22	struction as is safe and practicable, consistent
23	with maintaining safe and continuous oper-
