Add at the end of subtitle E of title VIII the following new section:

1	SEC. 8 REPORT ON SMALL BUSINESS CONCERNS
2	OWNED AND CONTROLLED BY WOMEN.
3	(a) In General.—Section 8(m) of the Small Busi-
4	ness Act (15 U.S.C. 637(m)) is amended by adding at the
5	end the following new paragraph:
6	"(9) Report.—Not later than May 1, 2023,
7	and annually thereafter, the Administrator shall sub-
8	mit to the Committee on Small Business of the
9	House of Representatives and the Committee on
10	Small Business and Entrepreneurship of the Senate
11	a report on small business concerns owned and con-
12	trolled by women. Such report shall include, for the
13	fiscal year preceding the date of the report, the fol-
14	lowing:
15	"(A) The total number of concerns cer-
16	tified as small business concerns owned and
17	controlled by women, disaggregated by the
18	number of concerns certified by—

1	"(i) the Administrator; or
2	"(ii) a national certifying entity ap-
3	proved by the Administrator.
4	"(B) The amount of fees, if any, charged
5	by each national certifying entity for such cer-
6	tification.
7	"(C) The total dollar amount and total
8	percentage of prime contracts awarded to small
9	business concerns owned and controlled by
10	women pursuant to paragraph (2) or pursuant
11	to a waiver granted under paragraph (3).
12	"(D) The total dollar amount and total
13	percentage of prime contracts awarded to small
14	business concerns owned and controlled by
15	women pursuant to paragraphs (7) and (8).
16	"(E) With respect to a contract incorrectly
17	awarded pursuant to this subsection because it
18	was awarded based on an industry in which
19	small business concerns owned and controlled
20	by women are not underrepresented—
21	"(i) the number of such contracts;
22	"(ii) the Federal agencies that issued
23	such contracts; and
24	"(iii) any steps taken by Adminis-
25	trator to train the personnel of such Fed-

1	eral agency on the use of the authority
2	provided under this subsection.
3	"(F) With respect to an examination de-
4	scribed in paragraph (5)(B)—
5	"(i) the number of examinations due
6	because of recertification requirements and
7	the actual number of such examinations
8	conducted; and
9	"(ii) the number of examinations con-
10	ducted for any other reason.
11	"(G) The number of small business con-
12	cerns owned and controlled by women that were
13	found to be ineligible to be awarded a contract
14	under this subsection as a result of an examina-
15	tion conducted pursuant to paragraph (5)(B) or
16	failure to request an examination pursuant to
17	section 127.400 of title 13, Code of Federal
18	Regulations (or a successor rule).
19	"(H) The number of small business con-
20	cerns owned and controlled by women that were
21	decertified.
22	"(I) Any other information the Adminis-
23	trator determines necessary.".
