7 "(c) OTHER DISEASES.—In the case of a covered vet-8 eran who files a claim for compensation under this chapter 9 for a disease other than a disease specified in subsection 10 (b) and the evidence is not sufficient to approve the claim, before denying the claim, the Secretary shall ensure that 11 12 the covered veteran receives a medical examination and 13 a medical opinion as to any causal link between the disease 14 and a covered toxin. In performing a medical examination 15 pursuant to this subsection, a medical examiner shall consider the total potential exposure of the veteran and the 16 synergistic effect of all combined toxins through inhala-17 tion, dermal exposure, and ingestion. 18

19 "(d) FORMAL EVALUATION.—(1) Not later than 180 20 days after the date of the enactment of this section, and 21 not less frequently than every two years thereafter, the 22 Secretary shall conduct a formal process, as described in 23 section 1173 of this title, to evaluate the connection be-24 tween diseases and covered toxins and to determine which 25 diseases have a positive association with a covered toxin. 3
