

**AMENDMENT TO H.R. 8790, AS REPORTED**  
**OFFERED BY MR. GARAMENDI OF CALIFORNIA**

Page 8, after line 8, insert the following (and redesignate subsequent paragraphs accordingly):

1           (18) SPECIAL DISTRICT.—The term “special  
2       district” means a political subdivision of a State  
3       that—

4                   (A) has significant budgetary autonomy or  
5       control;

6                   (B) was created by or pursuant to the laws  
7       of the State for the purpose of performing a  
8       limited and specific governmental or proprietary  
9       function; and

10                  (C) is distinct from any other local govern-  
11       ment unit within the State.

Page 29, before line 1, insert the following (and redesignate subsequent subparagraphs accordingly):

12                   (A) in section 3 (16 U.S.C. 6502), by in-  
13       serting at the end the following:

14                  “(3) LOCAL GOVERNMENT.—The term ‘local  
15       government’ means a county, municipality, or special  
16       district.

1           “(4) SPECIAL DISTRICT.—The term ‘special dis-  
2       trict’ means a political subdivision of a State that—

3           “(A) has significant budgetary autonomy  
4       or control;

5           “(B) was created by or pursuant to the  
6       laws of the State for the purpose of performing  
7       a limited and specific governmental or propri-  
8       etary function; and

9           “(C) is distinct from any other local gov-  
10       ernment unit within the State.”.

Page 30, line 15, strike “and”.

Page 30, after line 15, insert the following (and re-  
designate subsequent paragraphs accordingly):

11           (2) in subsection (a), by inserting the following:

12           “(11) SPECIAL DISTRICT.—The term ‘special  
13       district’ means a political subdivision of a State  
14       that—

15           “(A) has significant budgetary autonomy  
16       or control;

17           “(B) was created by or pursuant to the  
18       laws of the State for the purpose of performing  
19       a limited and specific governmental or propri-  
20       etary function; and

1                   “(C) is distinct from any other local gov-  
2                   ernment unit within the State.”.

“tribe,”.

“Indian tribe,”.
