6 (a) IN GENERAL.—Each covered person that is re7 quired to submit a subcontracting plan under paragraph
8 (4) or (5) of section 8(d) of the Small Business Act (15
9 U.S.C. 637(d)) for a contract shall update such subcon10 tracting plan to include the following:

(1) The names, addresses, phone numbers,
types of business, and North American Industrial
Classification System code of the small business concerns owned and controlled by socially and economically disadvantaged individuals that were considered
or solicited as subcontractors.

3 (A) increase the number of such concerns
4 in the subcontracting plan for subsequent years
5 of contract performance; and

6 (B) increase the dollar amount under the 7 contract allocated for goods and services pro-8 vided by such concerns.

9 (b) OUTREACH.—The Secretary of Defense, acting 10 through the Defense Contract Management Agency, shall 11 increase outreach on contracting with the Department of 12 Defense (either as a prime contractor or a subcontractor 13 at any tier) to small business concerns owned and con-14 trolled by socially and economically disadvantaged individ-15 uals by taking the following actions:

16 (1) Providing briefings, electronic and printed 17 announcements, and other information to minority 18 business associations, nonprofit organizations, and 19 national and local business organizations that rep-20 resent minority businesses and small business con-21 cerns owned and controlled by socially and economically disadvantaged individuals about such con-22 23 tracting opportunities.

24 (2) Directly contacting small business concerns25 owned and controlled by socially and economically

disadvantaged individuals through the means de scribed in subsection (a)(3)(D) about such con tracting opportunities.

4 (c) ENFORCEMENT.—

5 (1)COMPLIANCE WITH SUBCONTRACTING 6 PLAN.—An covered person described in subsection 7 (a) that is awarded a prime contract and granted a 8 modification of a contract by the Secretary of De-9 fense under such subsection shall remain in compli-10 ance with the terms of the updated subcontracting 11 plan during the term of performance of the contract 12 before receiving any amounts related to such modification. 13

14 (2)SUBSEQUENT CONTRACTS.—If a covered 15 person described in paragraph (1) submits an offer 16 for a subsequent contract with the Department of 17 Defense through a sealed bid or negotiated acquisi-18 tion proposal and the Secretary determines such cov-19 ered person is not in compliance with in a subcon-20 tracting plan described in subsection (a), the Sec-21 retary may not award the subsequent contract to 22 such contractor.

23 (d) ACCOUNTABILITY.—The appropriate head of a24 Federal agency shall consider the performance of a con-

 evaluation of the performance of the contracting officer.
 (e) DEFINITIONS.—In this section:

4 (1) The term "small business concerns owned
5 and controlled by socially and economically disadvan6 taged individuals" has the meaning given under sec7 tion 8(d)(3)(C) of the Small Business Act (15
8 U.S.C. 637(d)(3)(C)).

9 (2) The term "covered person" means an ap10 parently successful offeror, bidder for a contract, or
11 contractor seeking a modification of a contract.
