At the end of subtitle D of title X, insert the following:

11	forces, groups, or individuals, full consideration
12	is given to any credible information relating to
13	violations of human rights by such entities.".
14	(2) in subsection $(d)(2)$ —
15	(A) in subparagraph (H), by inserting ",
16	including the promotion of good governance and
17	rule of law and the protection of civilians and
18	human rights" before the period at the end;

1	(B) in subparagraph (I)—
2	(i) by striking the period at the end
3	and inserting "or violations of the Geneva
4	Conventions of 1949, including—"; and
5	(ii) by adding at the end the following
6	new clauses:
7	"(i) vetting units receiving such sup-
8	port for violations of human rights;
9	"(ii) providing human rights training
10	to units receiving such support; and
11	"(iii) providing for the investigation of
12	allegations of violations of human rights
13	and termination of such support in cases
14	of credible information of such violations.";
15	and
16	(C) by adding at the end the following new
17	subparagraph:
18	"(J) A description of the human rights
19	record of the recipient, including for purposes
20	of section 362 of this title, and any relevant at-
21	tempts by such recipient to remedy such
22	record.";
23	(3) in subsection (i)(3) by adding at the end the
24	following new subparagraph:

1	"(I) An assessment of how support pro-
2	vided under this section advances United States
3	national security priorities and aligns with
4	other United States Government efforts to ad-
5	dress underlying risk factors of terrorism and
6	violent extremism."; and
7	(4) by adding at the end the following new sub-
8	section:
9	"(j) Prohibition on Use of Funds.—(1) Except
10	as provided in paragraphs (2) and (3), no funds may be
11	used to provide support to any foreign forces, irregular
12	forces, groups, or individuals if the Secretary of Defense
13	has credible information that the unit has committed a
14	gross violation of human rights.
15	"(2) The Secretary of Defense may waive the prohibi-
16	tion under paragraph (1) if the Secretary determines that
17	the waiver is required by extraordinary circumstances.
18	"(3) The prohibition under paragraph (1) shall not
19	apply with respect to the foreign forces, irregular forces,
20	groups, or individuals of a country if the Secretary of De-
21	fense determines that—
22	"(A) the government of such country has taken
23	all necessary corrective steps; or

1 "(B) the support is necessary to assist in dis-2 aster relief operations or other humanitarian or na-3 tional security emergencies.".
