At the end of subtitle C of title XVII, add the following new section:

1	SEC. 17 ANNUAL GFA STEERING COMMITTEE MEETING
2	ON POLICY ALIGNMENT.
3	(a) Responsibilities.—At least once annually, a
4	GFA Steering Committee meeting shall be held to—
5	(1) evaluate the extent to which the strategic
6	approach and objectives of the plans developed under
7	section 506 of the Global Fragility Act of 2019 (22
8	U.S.C. 9805) align to current United States policy
9	priorities in the relevant countries and region;
10	(2) assess the elements described in section
11	505(a)(1)(C) of the Global Fragility Act of 2019 (22
12	U.S.C. 9804(a)(1)(C)) with respect to the selection
13	of priority countries and priority regions for pur-
14	poses of the implementation of the Global Fragility
15	Act of 2019 (22 U.S.C. 9801 et seq.), and consider
16	steps to address any deficiencies in such elements;
17	(3) determine any beneficial updates or amend-
18	ments to the plans described in paragraph (1) or
19	United States policy priorities with respect to pri-

1	ority countries or regions to ensure effective short
2	and long-term alignment; and
3	(4) consider any beneficial steps to increase
4	alignment of relevant diplomatic, development, and
5	security assistance and cooperation activities with
6	the objectives of the plans described in paragraph
7	(1).
8	(b) Participation in Steering Committee Meet-
9	INGS.—For purposes of each meeting conducted to fulfill
10	the requirements of subsection (a), the GFA Steering
11	Committee shall be chaired by an official of the Depart-
12	ment of State holding a position at or above the level of
13	the Deputy Secretary of State and the Deputy National
14	Security Advisor and shall include the participation of—
15	(1) the Under Secretary of State for Civilian
16	Security, Democracy, and Human Rights;
17	(2) the Under Secretary of State for Political
18	Affairs;
19	(3) the Administrator of the United States
20	Agency for International Development;
21	(4) the Deputy Administrator of United States
22	Agency for International Development for Policy and
23	Programming;
24	(5) the Under Secretary of Defense for Policy;

1	(6) the Under Secretary of Treasury for Inter-
2	national Affairs;
3	(7) each relevant Assistant Secretary of the De-
4	partment of State;
5	(8) each relevant Assistant Administrator of the
6	United States Agency for International Develop-
7	ment;
8	(9) the Senior Director of the National Security
9	Council;
10	(10) all relevant, equivalent-level Federal offi-
11	cials with regional or functional responsibility for
12	planning, coordination, or implementation of diplo-
13	matic, development, or security cooperation or as-
14	sistance activities in a country designated as a "pri-
15	ority country" or that is part of a designated "pri-
16	ority region" for purposes of the Global Fragility
17	Act of 2019; and
18	(11) all Federal officials holding positions of
19	equivalent level from all other relevant Federal de-
20	partments and agencies that conduct activities rel-
21	evant to conflict prevention or stabilization in such
22	a priority county or region.
