

**AMENDMENT TO  
RULES COMMITTEE PRINT 117-13  
OFFERED BY MS. JAYAPAL OF WASHINGTON**

At the end of subtitle E of title VI, insert the following:

**1 SEC. 642. APPROVAL OF CERTAIN ACTIVITIES BY RETIRED  
2 AND RESERVE MEMBERS OF THE UNI-  
3 FORMED SERVICES.**

4 (a) CLARIFICATION OF ACTIVITIES FOR WHICH AP-  
5 PROVAL REQUIRED.—Section 908 of title 37, United  
6 States Code, is amended—

7 (1) in subsection (a)—

8 (A) in the matter preceding paragraph

9 (1)—

10 (i) by striking “subsection (b)” and  
11 inserting “subsections (b) and (c)”; and

12 (ii) by inserting “, accepting payment  
13 for speeches, travel, meals, lodging, or reg-  
14 istration fees, or accepting a non-cash  
15 award,” after “that employment”); and

16 (B) in paragraph (2), by striking “armed  
17 forces” and inserting “armed forces, except  
18 members serving on active duty under a call or

1 order to active duty for a period in excess of 30  
2 days”;

3 (2) in the heading of subsection (b), by insert-  
4 ing “FOR EMPLOYMENT AND COMPENSATION” after  
5 “APPROVAL REQUIRED”;

6 (3) by redesignating subsections (c) and (d) as  
7 subsections (d) and (e), respectively; and

8 (4) by inserting after subsection (b) the fol-  
9 lowing new subsection (c):

10 “(c) APPROVAL REQUIRED FOR CERTAIN PAYMENTS  
11 AND AWARDS.—A person described in subsection (a) may  
12 accept payment for speeches, travel, meals, lodging, or  
13 registration fees described in that subsection, or accept a  
14 non-cash award described in that subsection, only if the  
15 Secretary concerned approves the payment or award.”.

16 (b) ANNUAL REPORTS ON APPROVALS.—Subsection  
17 (d) of such section, as redesignated by subsection (a)(3)  
18 of this section, is amended—

19 (1) by inserting “(1)” before “Not later than”;

20 (2) in paragraph (1), as designated by para-  
21 graph (1) of this subsection, by inserting “, and  
22 each approval under subsection (c) for a payment or  
23 award described in subsection (a),” after “in sub-  
24 section (a)”;

1 (3) by adding at the end the following new  
2 paragraph:

3 “(2) The report under paragraph (1) on an approval  
4 described in that paragraph with respect to an officer shall  
5 set forth the following:

6 “(A) The foreign government providing the em-  
7 ployment or compensation or payment or award.

8 “(B) The duties, if any, to be performed in con-  
9 nection with the employment or compensation or  
10 payment or award.

11 “(C) The total amount of compensation, if any,  
12 or payment to be provided.”.

13 (c) CONFORMING AMENDMENTS.—

14 (1) SECTION HEADING.—The heading of such  
15 section is amended to read as follows:

16 **“§ 908. Reserves and retired members: acceptance of**  
17 **employment, payments, and awards from**  
18 **foreign governments”.**

19 (2) TABLE OF SECTIONS.—The table of sections  
20 at the beginning of chapter 17 of such title is  
21 amended by striking the item relating to section 908  
22 and inserting the following new item:

“908. Reserves and retired members: acceptance of employment, payments, and  
awards from foreign governments.”.
