At the end of subtitle A of title XVII, insert the following:

1	SEC. 17 REPORT ON GOVERNMENT POLICE TRAINING
2	AND EQUIPPING PROGRAMS.
3	(a) Report.—Not later than one year after the date
4	of the enactment of this Act, the President shall submit
5	to Congress a report on United States Government police
6	training and equipping programs outside the United
7	States.
8	(b) Elements.—The report required under para-
9	graph (1) shall include the following:
10	(1) A list of all United States Government de-
11	partments and agencies involved in implementing po-
12	lice training and equipping programs.
13	(2) A description of the scope, size, and compo-
14	nents of all police training and equipping programs
15	for fiscal years 2023, 2024, and 2025, including, for
16	each such program—
17	(A) the name of each country that received
18	assistance under the program;

1	(B) for each training activity, the number
2	of foreign personnel provided training, their
3	units of operation, location of the training, cost
4	of the activity, the United States unit involved,
5	and the nationality and unit of non-United
6	States training personnel, if any, involved in
7	each activity;
8	(C) the purpose and objectives of the pro-
9	gram;
10	(D) the funding and personnel levels for
11	the program in each such fiscal year;
12	(E) the authority under which the program
13	is conducted;
14	(F) the name of the United States Govern-
15	ment department or agency with lead responsi-
16	bility for the program and the mechanisms for
17	oversight of the program; and
18	(G) the metrics for measuring the results
19	of the program.
20	(3) An assessment of the requirements for po-
21	lice training and equipping programs, and what
22	changes, if any, are required to improve the capacity
23	of the United States Government to meet such re-
24	auirements.

1	(4) An evaluation of the appropriate role of
2	United States Government departments and agen-
3	cies in coordinating on and carrying out police train-
4	ing and equipping programs.
5	(5) An evaluation of the appropriate role of
6	contractors in carrying out police training and
7	equipping programs, and what modifications, if any,
8	are needed to improve oversight of such contractors.
9	(6) Recommendations for legislative modifica-
10	tions, if any, to existing authorities relating to police
11	training and equipping programs.
12	(c) FORM OF REPORT.—The report required under
13	this section shall be submitted in unclassified form, but
14	may include a classified annex.
15	(d) Public Availability Internet.—All unclassi-
16	fied portions of the report required under this section shall
17	be made publicly available on an appropriate internet
18	website.
19	(e) Definition.—In this section, the term "police"
20	includes national police, gendarmerie, counter-narcotics
21	police, counterterrorism police, formed police units, border
22	security, and customs.
