

AMENDMENT TO RULES COMMITTEE PRINT

OFFERED BY MS. KELLY OF ILLINOIS

Add at the end of subtitle C of title XVIII the following:

1 **SEC. 18___. EXPAND REPORTING ON SUBCONTRACTS AND**
2 **SUBAWARDS.**

3 (a) IN GENERAL.—Section 2 of the Federal Funding
4 Accountability and Transparency Act of 2006 (31 U.S.C.
5 6101 note) is amended—

6 (1) in subsection (b)—

7 (A) in paragraph (1)—

8 (i) in the matter preceding subpara-
9 graph (A), by striking “Not later than
10 January 1, 2008, the” and inserting
11 “The”;

12 (ii) in subparagraph (F)(ii), by strik-
13 ing the period at the end and inserting a
14 semicolon;

15 (iii) by redesignating subparagraph
16 (G) as subparagraph (H); and

17 (iv) by inserting after subparagraph
18 (F) the following new subparagraph:

1 “(G) the race, ethnicity, veteran status,
2 and sex of the five most highly compensated of-
3 ficers of the entity; and”;

4 (B) in paragraph (2)—

5 (i) by striking “The website” and in-
6 serting the following:

7 “(A) IN GENERAL.—Except as provided in
8 subparagraph (B), the website”;

9 (ii) by adding at the end the following
10 new subparagraph:

11 “(B) PRIME AND SUBAWARD INFORMA-
12 TION.—With respect to the information de-
13 scribed in paragraph (1)(G), the website shall
14 include data for each fiscal year beginning after
15 the date of the enactment of this subpara-
16 graph.”;

17 (2) in subsection (g)(2)—

18 (A) in subparagraph (B), by striking “;
19 and” and inserting a semicolon;

20 (B) in subparagraph (C), by striking the
21 period at the end and inserting “; and”;

22 (C) by adding at the end the following new
23 subparagraph:

24 “(D) the dollar amount of each sub-
25 contract and subgrant awarded under a Federal

1 award with respect to which subsection (b)(1)
2 applies by the recipient of such Federal award
3 pursuant to a Federal law or regulation.”.

4 (b) WEBSITE UPDATE DEADLINE.—The Office of
5 Management and Budget shall comply with the require-
6 ments of section 2(b)(1) of the Federal Funding Account-
7 ability and Transparency Act of 2006 (31 U.S.C. 6101
8 note), as amended by this section, not later than 180 days
9 after the date of the enactment of this Act.

10 (c) FEDERAL ACQUISITION REGULATION REVI-
11 SIONS.—The Federal Acquisition Regulatory Council es-
12 tablished under section 1302(a) of title 41, United States
13 Code, shall consider and evaluate public comments on any
14 regulations proposed pursuant to the amendments made
15 by this section and shall promptly issue a final rule, if
16 appropriate and consistent with applicable law.
