SUPPORT FOR TAIWAN ADMISSION TO IMF; TES-2 TIMONY. 3 (a) SUPPORT FOR TAIWAN ADMISSION TO IMF.— 4 (1) IN GENERAL.—The United States Governor 5 of the International Monetary Fund (in this subsection referred to as the "Fund") shall use the 6 voice and vote of the United States to vigorously 7 8 support-9 (A) the admission of Taiwan as a member 10 of the Fund, to the extent that admission is 11 sought by Taiwan; 12 (B) participation by Taiwan in regular sur-13 veillance activities of the Fund with respect to 14 the economic and financial policies of Taiwan, 15 consistent with Article IV consultation proce-16 dures of the Fund; 17 (C) employment opportunities for Taiwan

3 (b) TESTIMONY REQUIREMENT.—In each of the 7 4 years following the date of enactment of this Act in which 5 the Secretary of the Treasury is required by section 1705(b) of the International Financial Institutions Act to 6 7 present testimony, the Secretary shall include in the testimony a description of the efforts of the United States to 8 9 support the greatest participation practicable by Taiwan at each international financial institution (as defined in 10 11 section 1701(c)(2) of such Act).
