

AMENDMENT TO RULES COMM. PRINT 118-36
OFFERED BY MRS. KIM OF CALIFORNIA

At the end of subtitle B of title XVII, add the following new section:

1 **SEC. 17___ . REVIEW OF SANCTIONS WITH RESPECT TO**
2 **HONG KONG.**

3 (a) DETERMINATION WITH RESPECT TO IMPOSITION
4 OF SANCTIONS.—Not later than 180 days after the date
5 of the enactment of this Act, the President shall submit
6 to the appropriate congressional committees a determina-
7 tion, including a detailed justification, of whether any per-
8 son listed in subsection (b) meets the criteria for the im-
9 sition of sanctions pursuant to—

10 (1) section 1263(b) of the Global Magnitsky
11 Human Rights Accountability Act (22 U.S.C.
12 10102(b));

13 (2) Executive Order 13818 (50 U.S.C. 1701
14 note; relating to blocking the property of persons in-
15 volved in serious human rights abuse or corruption);

16 (3) section 7 of the Hong Kong Human Rights
17 and Democracy Act of 2019 (22 U.S.C. 5701 note;
18 Public Law 116-76);

1 (4) section 6 of the Hong Kong Autonomy Act
2 (22 U.S.C. 5701 note; Public Law 116–149); or

3 (5) Executive Order 13936 (22 U.S.C. 5701
4 note; relating to Hong Kong Normalization).
