**OFFERED BY MR. KING OF IOWA**

In division F, strike section 543.

At the end of division F (before the short title), insert the following:

1 TITLE VII

2 ADDITIONAL GENERAL PROVISIONS

3 SEC. 701. (a) No funds, resources or fees made avail-  
4 able to the Secretary of Homeland Security, or to any  
5 other official of a Federal agency, by this division or by  
6 any other Act, for any fiscal year, including any deposits  
7 into the “Immigration Examinations Fee Account” estab-  
8 lished under section 286(m) of the Immigration and Na-  
9 tionality Act (8 U.S.C. 1356(m)), may be used to consider  
10 or adjudicate any new, renewal or previously denied appli-  
11 cation for any alien requesting consideration of deferred  
12 action, as authorized by any of the following (or any sub-  
13 stantially similar policy changes issued or taken on or  
14 after May 1, 2017, whether set forth in memorandum, Ex-  
15 ecutive order, regulation, directive, or by other action):

1           (1) The memorandum from the Secretary of  
2           Homeland Security entitled “Exercising Prosecu-  
3           torial Discretion with Respect to Individuals Who  
4           Came to the United States as Children” dated June  
5           15, 2012.

6           (2) The memorandum from the Secretary of  
7           Homeland Security entitled “Exercising Prosecu-  
8           torial Discretion with Respect to Individuals Who  
9           Came to the United States as Children and with Re-  
10          spect to Certain Individuals Who Are the Parents of  
11          U.S. Citizens or Permanent Residents” dated No-  
12          vember 20, 2014.

13          (b) The budgetary effects of this section shall not be  
14          entered on either PAYGO scorecard maintained pursuant  
15          to section 4(d) of the Statutory Pay-As-You-Go Act of  
16          2010.

17          (c) Notwithstanding Rule 3 of the Budget  
18          Scorekeeping Guidelines set forth in the joint explanatory  
19          statement of the committee of conference accompanying  
20          Conference Report 105-217 and section 250(c)(8) of the  
21          Balanced Budget and Emergency Deficit Control Act of  
22          1985, the budgetary effects of this section shall not be  
23          estimated—

24                 (1) for purposes of section 251 of the such Act;  
25          and

1           (2) for purposes of paragraph 4(C) of section 3  
2           of the Statutory Pay-As-You-Go Act of 2010 as  
3           being included in an appropriation Act.

4           SEC. 702. In addition to amounts otherwise made  
5           available by this Act, \$1,900,000,000 is appropriated for  
6           construction of a wall along the international border be-  
7           tween the United States and Mexico.

8           SEC. 703. None of the funds made available by this  
9           division may be obligated or expended in the form of an  
10          award to any State, or political subdivision of a State,  
11          that—

12           (1) has in effect any law, policy, or procedure  
13          in contravention of subsection (a) or (b) of section  
14          642 of the Illegal Immigration Reform and Immig-  
15          grant Responsibility Act of 1996 (8 U.S.C. 1373);  
16          or

17           (2) prohibits State or local law enforcement of-  
18          ficials from gathering information regarding the citi-  
19          zenship or immigration status, lawful or unlawful, of  
20          any individual.

          At the end of division H (before the short title), in-  
sert the following:

21          SEC. 534. None of the funds made available by this  
22          Act may be made available for any purpose to—

- 1 (1) Planned Parenthood Federation of America,  
2 Inc.;
- 3 (2) any affiliate or clinic of Planned Parenthood  
4 Federation of America, Inc.; or
- 5 (3) any successor of Planned Parenthood Fed-  
6 eration of America, Inc. or any such affiliate or clin-  
7 ic of such successor.

At the end of the committee print, add the following:

8 **DIVISION O—ADDITIONAL GENERAL**  
9 **PROVISIONS**

10 SEC. 101. None of the funds made available by divi-  
11 sions A through L of this Act may be used to fund the  
12 implementation of the Joint Comprehensive Plan of Action  
13 regarding Iran and submitted to the Congress on July 19,  
14 2015, or any side deals to the nuclear agreement (includ-  
15 ing all related materials and annexes) between the Inter-  
16 national Atomic Energy Agency (IAEA) and Iran.

17 SEC. 102. Amounts made available by divisions A  
18 through L may not be used to carry out any provisions  
19 of the Patient Protection and Affordable Care Act (Public  
20 Law 111–148), the Health Care and Education Reconcili-  
21 ation Act of 2010 (Public Law 111–152), or the amend-  
22 ments made by either such Act.
