At the end of subtitle A of title II, insert the following:

1 **SEC. 2___ . FUNDING FOR COVID-19 VACCINE PRODUCTION.**

2 (a) INCREASE.—Notwithstanding the amounts set
3 forth in the funding tables in division D, the amount au-
4 thorized to be appropriated in section 201 for research,
5 development, test, and evaluation, as specified in the cor-
6 responding funding table in section 4201, for Research,
7 Defense-wide, Basic Research, Chemical and Biological
8 Defense Program, line 008 is hereby increased by
9 \$5,834,900,000.

10 (b) OFFSET.—Notwithstanding the amounts set forth
11 in the funding tables in division D, the amount authorized
12 to be appropriated in section 101 for procurement, as
13 specified in the corresponding funding table in section
14 4101, for Aircraft Procurement, Navy, Combat Aircraft,
15 line 001 is hereby reduced by \$970,000,000.

16 (c) OFFSET.—Notwithstanding the amounts set forth
17 in the funding tables in division D, the amount authorized
18 to be appropriated in section 101 for procurement, as

2 4101, for Aircraft Procurement, Navy, Combat Aircraft,
3 line 009 is hereby reduced by \$250,000,000.

4 (d) OFFSET.—Notwithstanding the amounts set forth

8 4101, for Aircraft Procurement, Navy, Combat Aircraft,
9 line 013 is hereby reduced by \$340,000,000.
