

AMENDMENT TO RULES COMMITTEE PRINT 117–

54

OFFERED BY MR. LARSEN OF WASHINGTON

At the end of subtitle B of title IX, add the following new section:

1 **SEC. 9___.** **SENSE OF CONGRESS ON THE ELECTRO-**
2 **MAGNETIC SPECTRUM SUPERIORITY STRAT-**
3 **EGY.**

4 (a) **FINDINGS.**—Congress finds the following:

5 (1) The Department of Defense released the
6 Electromagnetic Spectrum Superiority Strategy (Oc-
7 tober 2020) and an Implementation Plan for such
8 strategy (August 2021).

9 (2) The purpose of the Electromagnetic Spec-
10 trum Superiority Strategy is to align electromagnetic
11 spectrum activities across the Department of De-
12 fense to solve persistent gaps in the ability of the
13 United States to project, achieve, and sustain elec-
14 tromagnetic spectrum superiority against adversaries
15 and peer competitors, most notably Russia and Peo-
16 ple’s Republic of China.

17 (3) A goal of the Electromagnetic Spectrum Su-
18 periority Strategy is to “Establish Effective EMS

1 Governance” to unify Department of Defense-wide
2 electromagnetic spectrum enterprise activities, de-
3 velop a continuous process improvement culture, and
4 promote policies that support Department of De-
5 fense electromagnetic spectrum capabilities and op-
6 erations.

7 (4) Electromagnetic spectrum superiority un-
8 derpins each of the four priorities of the 2022 Na-
9 tional Defense Strategy of the Department of De-
10 fense.

11 (5) The projecting, achievement, and
12 sustainment of electromagnetic spectrum superiority
13 is inherently a joint operational mission that is fun-
14 damental to the success of military missions carried
15 out by the United States and its allies across all
16 warfighting domains.

17 (6) Electromagnetic spectrum operations lead-
18 ership in the Pentagon must be consolidated and un-
19 ambiguous to address persistent gaps in coordina-
20 tion of joint electronic warfare among the services
21 and fragmentation in guidance from leadership in
22 the Department of Defense.

23 (b) SENSE OF CONGRESS.—It is the sense of Con-
24 gress that the Secretary of Defense—

1 (1) should provide to Congress an unclassified
2 version of the Implementation Plan for the Electro-
3 magnetic Spectrum Superiority Strategy by not later
4 than March 1, 2023; and

5 (2) as part of implementing the Electro-
6 magnetic Spectrum Superiority Strategy, should—

7 (A) strengthen governance reforms to en-
8 sure necessary senior operational leadership;
9 and

10 (B) provide a coherent response to per-
11 sistent gaps in joint electromagnetic spectrum
12 operations across the areas of Doctrine, Organi-
13 zation, Training, Materiel, Leadership, Per-
14 sonnel, Facilities and Policy (DOTMLPF–P).
