3	SEC. 501. SPECIAL BASE RATES OF PAY FOR WILDLAND
4	FIREFIGHTERS.
5	(a) IN GENERAL.—Subchapter III of chapter 53 of
6	title 5, United States Code, is amended by inserting after
7	section 5332 the following:
8	" $\S$ 5332a. Special base rates of pay for wildland fire-
9	fighters
10	"(a) Definitions.—In this section—
11	"(1) the term 'firefighter' means an employee
12	who—
13	"(A) is a firefighter within the meaning of
14	section 8331(21) or section 8401(14);
15	"(B) in the case of an employee who holds
16	a supervisory or administrative position and is
17	subject to subchapter III of chapter 83, but
18	who does not qualify to be considered a fire-
19	fighter within the meaning of section 8331(21),
20	would otherwise qualify if the employee had

1	transferred directly to that position after serv-
2	ing as a firefighter within the meaning of that
3	section;
4	"(C) in the case of an employee who holds
5	a supervisory or administrative position and is
6	subject to chapter 84, but who does not qualify
7	to be considered a firefighter within the mean-
8	ing of section 8401(14), would otherwise qualify
9	if the employee had transferred directly to that
10	position after performing duties described in
11	section 8401(14)(A) for at least 3 years; or
12	"(D) in the case of an employee who is not
13	subject to subchapter III of chapter 83 or chap-
14	ter 84, holds a position that the Office of Per-
15	sonnel Management determines would satisfy
16	subparagraph (A), (B), or (C) if the employee
17	were subject to subchapter III of chapter 83 or
18	chapter 84;
19	"(2) the term 'General Schedule base rate'
20	means an annual rate of basic pay established under
21	section 5332 before any additions, such as a locality-
22	based comparability payment under section 5304 or
23	5304a or a special rate supplement under section
24	5305;

1	"(3) the term 'special base rate' means an an-
2	nual rate of basic pay payable to a wildland fire-
3	fighter, before any additions or reductions, that re-
4	places the General Schedule base rate otherwise ap-
5	plicable to the wildland firefighter and that is ad-
6	ministered in the same manner as a General Sched-
7	ule base rate; and
8	"(4) the term 'wildland firefighter' means a
9	firefighter—
10	"(A) who is employed by the Forest Serv-
11	ice or the Department of the Interior; and
12	"(B) the duties of the position of whom
13	primarily relate to fires occurring in forests,
14	range lands, or other wildlands, as opposed to
15	structural fires.
16	"(b) Special Base Rates of Pay.—
17	"(1) Entitlement to special rate.—Not-
18	withstanding section 5332, a wildland firefighter is
19	entitled to a special base rate at grades 1 through
20	15, which shall—
21	"(A) replace the otherwise applicable Gen-
22	eral Schedule base rate for the wildland fire-
23	fighter;
24	"(B) be basic pay for all purposes, includ-
25	ing the purpose of computing a locality-based

1	comparability payment under section 5304 or
2	5304a; and
3	"(C) be computed as described in para-
4	graph (2) and adjusted at the time of adjust-
5	ments in the General Schedule.
6	"(2) Computation.—
7	"(A) IN GENERAL.—The special base rate
8	for a wildland firefighter shall be derived by in-
9	creasing the otherwise applicable General
10	Schedule base rate for the wildland firefighter
11	by the following applicable percentage for the
12	grade of the wildland firefighter and rounding
13	the result to the nearest whole dollar:
14	"(i) For GS-1, 42 percent.
15	"(ii) For GS-2, 39 percent.
16	"(iii) For GS-3, 36 percent.
17	"(iv) For GS-4, 33 percent.
18	"(v) For GS-5, 30 percent.
19	"(vi) For GS-6, 27 percent.
20	"(vii) For GS-7, 24 percent.
21	"(viii) For GS-8, 21 percent.
22	"(ix) For GS-9, 18 percent.
23	"(x) For GS-10, 15 percent.
24	"(xi) For GS-11, 12 percent.
25	"(xii) For GS-12, 9 percent.

1	"(xiii) For GS-13, 6 percent.
2	"(xiv) For GS-14, 3 percent.
3	"(xv) For GS-15, 1.5 percent.
4	"(B) Hourly, daily, weekly, or bi-
5	WEEKLY RATES.—When the special base rate
6	with respect to a wildland firefighter is ex-
7	pressed as an hourly, daily, weekly, or biweekly
8	rate, the special base rate shall be computed
9	from the appropriate annual rate of basic pay
10	derived under subparagraph (A) in accordance
11	with the rules under section 5504(b).".
12	(b) Amendment to Prevailing Rate Determina-
13	TIONS.—Section 5343 of title 5, United States Code, is
14	amended by adding at the end the following:
15	``(g)(1) For a prevailing rate employee described in
16	section $5342(a)(2)(A)$ who is a wildland firefighter, as de-
17	fined in section 5332a(a), the Secretary of Agriculture or
18	the Secretary of the Interior (as applicable) shall increase
19	the wage rates of that employee by an amount (determined
20	at the sole and exclusive discretion of the applicable Sec-
21	retary after consultation with the other Secretary) that is
22	generally consistent with the percentage increases given
23	to wildland firefighters in the General Schedule under sec-
24	tion 5332a.

- 2 shall be basic pay for the same purposes as the wage rate
- 3 otherwise established under this section.
- 4 "(3) An increase under this subsection may not cause
- 5 the wage rate of an employee to increase to a rate that

- 7 rate for level IV of the Executive Schedule.".

11	"(a) Definitions.—In this section—
12	"(1) the term 'appropriate committees of Con-

14	"(A) the Committee on Appropriations of

16	"(B) the Committee on Oversight and Ac-
17	countability of the House of Representatives;
18	"(C) the Committee on Agriculture of the
19	House of Representatives;
20	"(D) the Committee on Natural Resources
21	of the House of Representatives;
22	"(E) the Committee on Appropriations of
23	the Senate;
24	"(F) the Committee on Homeland Security
25	and Governmental Affairs of the Senate;

1	"(G) the Committee on Energy and Nat-
2	ural Resources of the Senate; and
3	"(H) the Committee on Agriculture, Nutri-
4	tion, and Forestry of the Senate;
5	"(2) the term 'covered employee' means an em-
6	ployee of the Forest Service or the Department of
7	the Interior who is—
8	"(A) a wildland firefighter, as defined in
9	section 5332a(a); or
10	"(B) certified by the applicable agency to
11	perform wildland fire incident-related duties
12	during the period that employee is deployed to
13	respond to a qualifying incident;
14	"(3) the term 'incident response premium pay'
15	means pay to which a covered employee is entitled
16	under subsection (c);
17	"(4) the term 'prescribed fire incident' means a
18	wildland fire originating from a planned ignition in
19	accordance with applicable laws, policies, and regula-
20	tions to meet specific objectives;
21	"(5) the term 'qualifying incident'—
22	"(A) means—
23	"(i) a wildfire incident, a prescribed
24	fire incident, or a severity incident; or

1	"(ii) an incident that the Secretary of
2	Agriculture or the Secretary of the Interior
3	determines is similar in nature to an inci-
4	dent described in clause (i); and
5	"(B) does not include an initial response
6	incident that is contained within 36 hours; and
7	"(6) the term 'severity incident' means an inci-
8	dent in which a covered employee is pre-positioned
9	in an area in which conditions indicate there is a
10	high risk of wildfires.
11	"(b) Eligibility.—A covered employee is eligible for
12	incident response premium pay under this section if—
13	"(1) the covered employee is deployed to re-
14	spond to a qualifying incident; and
15	"(2) the deployment described in paragraph (1)
16	is—
17	"(A) outside of the official duty station of
18	the covered employee; or
19	"(B) within the official duty station of the
20	covered employee and the covered employee is
21	assigned to an incident-adjacent fire camp or
22	other designated field location.
23	"(c) Entitlement to Incident Response Pre-
24	MIUM PAY.—

1	"(1) In general.—A covered employee who
2	satisfies the conditions under subsection (b) is enti-
3	tled to premium pay for the period in which the cov-
4	ered employee is deployed to respond to the applica-
5	ble qualifying incident.
6	"(2) Computation.—
7	"(A) FORMULA.—Subject to subpara-
8	graphs (B) and (C), premium pay under para-
9	graph (1) shall be paid to a covered employee
10	at a daily rate of 450 percent of the hourly rate
11	of basic pay of the covered employee for each
12	day that the covered employee satisfies the re-
13	quirements under subsection (b), rounded to
14	the nearest whole cent.
15	"(B) Limitation.—Premium pay under
16	this subsection may not be paid—
17	"(i) with respect to a covered em-
18	ployee for whom the annual rate of basic
19	pay is greater than that for step 10 of GS-
20	10, at a daily rate that exceeds the daily
21	rate established under subparagraph (A)
22	for step 10 of GS-10; or
23	"(ii) to a covered employee in a total
24	amount that exceeds \$9,000 in any cal-
25	endar year.

1	"(C) Adjustments.—
2	"(i) Assessment.—The Secretary of
3	Agriculture and the Secretary of the Inte-
4	rior shall assess the difference between the
5	average total amount of compensation that
6	was paid to covered employees, by grade,
7	in fiscal years 2023 and 2024.
8	"(ii) Report.—Not later than 180
9	days after the date that is 1 year after the
10	effective date of this section, the Secretary
11	of Agriculture and the Secretary of the In-
12	terior shall jointly publish a report on the
13	results of the assessment conducted under
14	clause (i).
15	"(iii) Administrative actions.—
16	After publishing the report required under
17	clause (ii), the Secretary of Agriculture
18	and the Secretary of the Interior, in con-
19	sultation with the Director of the Office of
20	Personnel Management, may, in the sole
21	and exclusive discretion of the Secretaries
22	acting jointly, administratively adjust the
23	amount of premium pay paid under this
24	subsection (or take other administrative
25	action) to ensure that the average annual

1	amount of total compensation paid to cov-
2	ered employees, by grade, is more con-
3	sistent with such amount that was paid to

2	for hours of paid leave or other paid time off during
3	which the premium pay is not payable; and
4	"(5) shall be disregarded in determining the
5	minimum wage and overtime pay to which a covered
6	employee is entitled under the Fair Labor Standards
7	Act of 1938 (29 U.S.C. 201 et seq.).".
