## OFFERED BY MR. LOUDERMILK OF GEORGIA

At the end of title XVII, add the following new section:

4	(a) Thresholds for Certain Currency Trans-

6	(1) CURRENCY TRANSACTION REPORTS.—The
7	Secretary of the Treasury shall—
8	(A) not later than the end of the 180-day
9	period beginning on the date of the enactment
10	of this Act, revise regulations issued with re-
11	spect to section 5313 of title 31, United States
12	Code, to update each \$10,000 threshold amount
13	in such regulations to \$30,000; and
14	(B) every 5 years, update each such
15	threshold amount to reflect the change in the
16	Consumer Price Index for All Urban Con-
17	sumers published by the Bureau of Labor Sta-
18	tistics of the Department of Labor.

1	(2) Threshold for reports relating to
2	COINS AND CURRENCY RECEIVED IN NONFINANCIAL
3	TRADE OR BUSINESS.—Section 5331 of title 31,
4	United States Code, is amended—
5	(A) by striking "\$10,000" each place such
6	term appears in heading or text and inserting
7	"\$30,000"; and
8	(B) by adding at the end the following:
9	"(e) UPDATES FOR INFLATION.—Every 5 years, the
10	Secretary of the Treasury shall update each dollar figure
11	under this section to reflect the change in the Consumer
12	Price Index for All Urban Consumers published by the
13	Bureau of Labor Statistics of the Department of Labor.".
14	(b) Thresholds for Suspicious Activity Re-
15	PORTS.—Not later than the end of the 180-day period be-
16	ginning on the date of the enactment of this Act, each
17	Federal department or agency that issues regulations with
18	respect to reports on suspicious transactions described
19	under section 5318(g) of title 31, United States Code,
20	shall update each \$5,000 threshold amount in such regula-
21	tions to \$10,000 and each \$2,000 threshold amount in
22	such regulation to \$3,000.
23	(c) Updating the Money Services Business
24	DEFINITION THRESHOLDS.—Not later than the end of the
25	180-day period beginning on the date of the enactment
