Add at the end of subtitle A of title XVII of division A the following:

1	SEC. 1703. THREAT ASSESSMENT OF TERRORIST THREATS
2	POSED BY INDIVIDUALS IN SYRIA WITH AN
3	AFFILIATION WITH A FOREIGN TERRORIST
4	ORGANIZATION OR A SPECIALLY DES-
5	IGNATED GLOBAL TERRORIST ORGANIZA-
6	TION.
7	(a) Terrorism Threat Assessment.—
8	(1) IN GENERAL.—The Secretary of Homeland
9	Security, in coordination with the Secretary of State
10	and the heads of other relevant Federal departments
11	or agencies, shall conduct a threat assessment of ter-
12	rorist threats to the United States posed by individ-
13	uals in Syria with an affiliation with a foreign ter-
14	rorist organization or a specially designated global
15	terrorist organization.
16	(2) Elements.—The threat assessment re-
17	quired under paragraph (1) shall include the fol-
18	lowing:

1	(A) An identification of the country of ori-
2	gin for each such individual included in such
3	threat assessment.
4	(B) A description of the foreign terrorist
5	organization or specially designated global ter-
6	rorist organization with which each such indi-
7	vidual is affiliated.
8	(C) A description of the following:
9	(i) The capability of the Department
10	of Homeland Security to identify, track,
11	and monitor such individuals.
12	(ii) Any associated challenges with
13	such capability.
14	(D) A description of any action of the De-
15	partment with respect to the following:
16	(i) Mitigating the terrorist threats to
17	the United States posed by such individ-
18	uals.
19	(ii) Preventing such individuals from
20	entering the United States.
21	(b) Congressional Notification.—Not later than
22	60 days after the date of the enactment of this Act, the
23	Secretary shall—

1	(1) submit to the appropriate congressional
2	committees the threat assessment required under
3	subsection (a); and
4	(2) provide a briefing to the appropriate con-
5	gressional committees on such assessment.
6	(c) DEFINITIONS.—In this section:
7	(1) Appropriate congressional commit-
8	TEES.—The term "appropriate congressional com-
9	mittees" means—
10	(A) the Committee on Homeland Security
11	and the Committee on Foreign Affairs of the
12	House of Representatives; and
13	(B) the Committee on Homeland Security
14	and Governmental Affairs and the Committee
15	on Foreign Relations of the Senate.
16	(2) Foreign terrorist organization.—The
17	term "foreign terrorist organization" means an or-
18	ganization designated as a foreign terrorist organiza-
19	tion under section 219 of the Immigration and Na-
20	tionality Act (8 U.S.C. 1189).
21	(3) Specially designated global ter-
22	RORIST ORGANIZATION.—The term "specially des-
23	ignated global terrorist organization" means an or-
24	ganization that has been designated as a specially
25	designated global terrorist organization by the Sec-

retary of State or the Secretary of the Treasury, as
the case may be, pursuant to Executive Order 13224

(50 U.S.C. 1701 note; relating to blocking property
and prohibiting transactions with persons who commit, threaten to commit, or support terrorism).
