1 Subtitle E—Other Matters

2 SEC. 33501. WATER REUSE INTERAGENCY WORKING 3 GROUP.

4 (a) IN GENERAL.—Not later than 180 days after the 5 date of enactment of this Act, the Administrator of the 6 Environmental Protection Agency (referred to in this sec-7 tion as the "Administrator"), shall establish a Water 8 Reuse Interagency Working Group (referred to in this sec-9 tion as the "Working Group").

10 (b) PURPOSE.—The purpose of the Working Group 11 is to develop and coordinate actions, tools, and resources 12 to advance water reuse across the United States, including through the implementation of a National Water Reuse 13 14 Action Plan that creates opportunities for water reuse in the mission areas of each of the Federal agencies included 15 16 in the Working Group under subsection (c) (referred to in this section as the "Action Plan"). 17

18 (c) CHAIRPERSON; MEMBERSHIP.—The Working19 Group shall be—

1	(1) chaired by the Administrator; and
2	(2) comprised of senior representatives from
3	such Federal agencies as the Administrator deter-
4	mines to be appropriate.
5	(d) Duties of the Working Group.—In carrying
6	out this section, the Working Group shall—
7	(1) with respect to water reuse, leverage the ex-
8	pertise of industry, the research community, non-
9	governmental organizations, and government;
10	(2) seek to foster water reuse as an important
11	component of integrated water resources manage-
12	ment;
13	(3) conduct an assessment of new opportunities
14	to advance water reuse and annually update the Ac-
15	tion Plan with new actions, as necessary, to pursue
16	those opportunities;
17	(4) seek to coordinate Federal programs and
18	policies to support the adoption of water reuse;
19	(5) consider how each Federal agency can ex-
20	plore and identify opportunities to support water
21	reuse through the programs and activities of that
22	Federal agency; and
23	(6) consult, on a regular basis, with representa-
24	tives of relevant industries, the research community,
25	and nongovernmental organizations.

(e) REPORT.—Not less frequently than once every 2
 years, the Administrator shall submit to Congress a report
 on the activities and findings of the Working Group.

4 (f) SUNSET.—

5 (1) IN GENERAL.—Subject to paragraph (2),
6 the Working Group shall terminate on the date that
7 is 6 years after the date of enactment of this Act.
8 (2) EXTENSION.—The Administrator may ex9 tend the date of termination of the Working Group
10 under paragraph (1).
