3 (a) NEW WELL CONSTRUCTION GRANTS.—Subtitle
4 A of the Consolidated Farm and Rural Development Act
5 (7 U.S.C. 1922–1936c) is amended by inserting after sec6 tion 306E the following:

#### 7 "SEC. 306F. NEW WELL CONSTRUCTION GRANTS.

8 "(a) IN GENERAL.—The Secretary shall provide 9 grants in accordance with this section to local govern-10 ments and public or private nonprofit entities for projects 11 designed to supply drinking water to rural communities 12 in which a significant number of dwellings with private 13 drinking water wells have wells that are not producing 14 water.

15 "(b) USE OF FUNDS.—Grants made under this sec-16 tion may be used—

1 "(1) for waterline extensions from existing sys-2 tems, laving of new waterlines, repairs or mainte-3 nance to an existing system, digging of new wells or 4 development of other sources of water designed to 5 replace sources of drinking water with high levels of 6 nitrates, equipment replacement, and hook-up fees; 7 and "(2) in the case of a project designed to benefit 8 9 a rural community outside the jurisdiction of the

a rural community outside the jurisdiction of the
grantee, to maintain existing water supplies of the
grantee that will be reduced as a result of the
project.

13 "(c) RURAL COMMUNITY.—In this section, the term14 'rural community' does not include—

"(1) any area in any city or town with a population in excess of 10,000 inhabitants according to
the most recent decennial census of the United
States; and

19 "(2) any area with a median household income
20 in excess of the State nonmetropolitan median
21 household income.

"(d) FULL FUNDING.—Grants under this section
shall be made in an amount equal to 100 percent of the
costs of the projects conducted under this section.

"(e) APPLICATION.—Subsection (h) of section 306A
 shall apply with respect to the administration of applica tions for grants under this section.

4 "(f) AUTHORIZATION OF APPROPRIATIONS.—There
5 is authorized to be appropriated to carry out this section
6 \$50,000,000 for each of fiscal years 2023 through 2027.".
7 (b) REPEAL.—Effective 5 years after the date of the

8 enactment of this section, section 306F of the Consoli9 dated Farm and Rural Development Act, as added by the
10 amendment made by subsection (a), is repealed.
