(e) Appropriate Congressional Committees De-3 FINED.—In this section, the term "appropriate congressional committees" means— 5 (1) the Committee on Foreign Affairs and the 6 7 Committee on Financial Services of the House of 8 Representatives; and (2) the Committee on Foreign Relations and 9 the Committee on Banking, Housing, and Urban Af-10 fairs of the Senate. 11
