

**AMENDMENT TO RULES COMM. PRINT 119–8**

**OFFERED BY MR. MEEKS OF NEW YORK**

At the end of title XVII, add the following:

**1 Subtitle C—Suspending Transfer of**  
**2 Property for Improper Trump**  
**3 Use Act**

**4 SEC. 1731. SHORT TITLE.**

**5** This subtitle may be cited as the “Suspending Trans-  
**6** fer of Property for Improper Trump Use Act”.

**7 SEC. 1732. DOCUMENTS REQUESTED.**

**8** Not later than 30 days after the date of the enact-  
**9** ment of this Act, the Secretary of State shall furnish to  
**10** the Committee on Foreign Affairs of the House of Rep-  
**11** resentatives and the Committee on Foreign Relations of  
**12** the Senate copies of all documents, Signal chats, memo-  
**13** randa, charts, tables, notes from meetings, audio record-  
**14** ings, records (including telephone and email records), cor-  
**15** respondence, artificial intelligence large language model  
**16** conversation transcripts, and any other communications  
**17** within the Department of State or the National Security  
**18** Council, or external communication with the State of  
**19** Qatar, pertaining to the transfer of an aircraft to the

1 United States Government, to be subsequently transferred  
2 to an entity controlled by President Donald J. Trump.

3 **SEC. 1733. REPORT.**

4 (a) IN GENERAL.—Not later than 30 days after the  
5 date of the enactment of this Act, the Secretary of State  
6 shall submit to the Committee on Foreign Affairs of the  
7 House of Representatives and the Committee on Foreign  
8 Relations of the Senate a report detailing the negotiations  
9 between the United States and Qatar pertaining to the  
10 transfer of an aircraft from Qatar to the United States,  
11 to be subsequently transferred to an entity controlled by  
12 President Trump.

13 (b) MATTERS TO BE INCLUDED.—The report re-  
14 quired by subsection (a) shall include the following:

15 (1) A description of any and all communica-  
16 tions pertaining to promises or commitments made  
17 or proposed to be made to Qatar in exchange for the  
18 transfer described in subsection (a), whether trans-  
19 mitted verbally or in writing.

20 (2) A recounting of any negotiation with private  
21 sector entities to receive contracts as a result of the  
22 potential or completed transfer described in sub-  
23 section (a).

1           (3) Information pertaining to the legal review  
2           conducted by the Secretary regarding the potential  
3           or completed transfer described in subsection (a).

4 **SEC. 1734. PROHIBITION ON FEDERAL FUNDING WITH RE-**  
5 **SPECT TO CERTAIN AIRCRAFT TRANSFERS.**

6           Notwithstanding any other provision of law, no Fed-  
7           eral funds are authorized to be appropriated or otherwise  
8           made available to take any action to support, facilitate,  
9           or execute the transfer of an aircraft owned by a foreign  
10          government or an entity controlled by a foreign govern-  
11          ment to the United States Government, the President of  
12          the United States, or to the Presidential Library of Presi-  
13          dent Trump.
