8 this Act for Department of Labor—Employee Benefits Se-  
9 curity Administration, Salaries and Expenses in excess of  
10 \$164,839,500 shall be used for Department of Labor—  
11 Employee Benefits Security Administration, Salaries and  
12 Expenses.

4 \$36,168,300 shall be used for Department of Labor—Of-  
5 fice of Labor-Management Standards, Salaries and Ex-  
6 penses.
