16	"(C) A summary of the legal basis for each
17	such Executive order.
18	"(D) The impact of the proposed Execu-
19	tive order on tribal communities and tribal sov-
20	ereignty, and an analysis of consultation with
21	federally recognized Indian tribes, if any, that
22	occurred prior to the issuance of the Executive
23	order.

1	"(E) A statement of the need for each
2	such Executive order and an analysis of how
3	the policies outlined in the order will impact the
4	economy, State and local government, public
5	health, safety, civil rights, or the environment.
6	"(F) The name, email address, and tele-
7	phone number of an official knowledgeable
8	about the contents of the Executive order that
9	the public may contact for additional informa-
10	tion about each Executive order.
11	"(G) A summary of the agencies affected
12	by the Executive order or that will implement
13	provisions of the Executive order, including any
14	estimates of anticipated additional staffing and
15	other costs broken down by agency.
16	"(H) A statement of whether the Executive
17	order conflicts with any policy or action taken
18	or planned by an agency or with Federal law.
19	"(I) An assessment of whether the imple-
20	mentation, compliance, administration, enforce-
21	ment, imposition of direct and indirect costs as-
22	sociated with the Executive order are ade-
23	quately justified by the assumed benefits to so-
