Amendment to H.R. 27 Offered by Mr. Moylan of Guam

At the end of the bill, add the following:

1	SEC PACIFIC COUNTERNARCOTICS STRATEGY ACT.
2	(a) Definitions.—Section 702 of the Office of Na-
3	tional Drug Control Policy Reauthorization Act of 1998
4	(21 U.S.C. 1701) is amended—
5	(1) by redesignating paragraphs (15) through
6	(17) as paragraphs (16) through (18) , respectively;
7	(2) by inserting after paragraph (14) the fol-
8	lowing:
9	"(15) STATE.—The term 'State' means each of
10	the several States of the United States, the District
11	of Columbia, and each territory or possession of the
12	United States.";
13	(3) in paragraph (18), as so redesignated—
14	(A) by redesignating subparagraphs (G)
15	and (H) as subparagraphs (H) and (I), respec-
16	tively; and
17	(B) by inserting after subparagraph (F)
18	the following:
19	"(G) activities to map, track, dismantle,
20	and disrupt the financial networks of drug traf-

1	ficking organizations, transnational criminal or-
2	ganizations, and money laundering organiza-
3	tions involved in the manufacture and traf-
4	ficking of drugs in the United States and in
5	foreign countries;"; and
6	(4) by adding at the end the following:
7	"(19) UNITED STATES.—The term 'United
8	States', when used in a geographical sense, means
9	the States and any waters within the jurisdiction of
10	the United States.".
11	(b) REQUIREMENT FOR PACIFIC COUNTER-
12	NARCOTICS STRATEGY.—Section 706(c)(3) of the Office
13	of National Drug Control Policy Reauthorization Act of
14	1998 (21 U.S.C. $1705(c)(3)$) is amended by adding at the
15	end the following:
16	"(D) REQUIREMENT FOR PACIFIC COUN-
17	TERNARCOTICS STRATEGY.—
18	"(i) PURPOSES.—The Pacific Coun-
19	ternarcotics Strategy shall—
20	"(I) set forth the strategy of the
21	Federal Government for preventing
22	the illegal trafficking of drugs through
23	the Pacific region into the United
24	States, including through ports of

1	entry, between ports of entry, and
2	across air and maritime approaches;
3	"(II) state the specific roles and
4	responsibilities of each relevant Na-
5	tional Drug Control Program agency
6	for implementing the strategy;
7	"(III) identify the specific re-
8	sources required to enable the relevant
9	National Drug Control Program agen-
10	cies to implement the strategy; and
11	"(IV) be designed to promote,
12	and not hinder, legitimate trade and
13	travel.
14	"(ii) Specific content related to
15	GUAM, THE NORTHERN MARIANA ISLANDS,
16	HAWAII, AND AMERICAN SAMOA.—The Pa-
17	cific Counternarcotics Strategy shall in-
18	clude—
19	"(I) a strategy to prevent the il-
20	legal trafficking of drugs to or
21	through Guam, the Northern Mariana
22	Islands, Hawaii, and American
23	Samoa, including measures to sub-
24	stantially reduce drug-related violent
25	crime on such islands; and

1	"(II) recommendations for addi-
2	tional assistance or authorities, if any,
3	needed by Federal, State, and local
4	law enforcement agencies relating to
5	the strategy, including an evaluation
6	of Federal technical and financial as-
7	sistance, infrastructure capacity build-
8	ing, and interoperability deficiencies.".
