3	(a) In General.—Title 5, United States Code, is
4	amended by inserting after section 5332 the following:
5	"§ 5332a. Special base rates of pay for wildland fire-
6	fighters
7	"(a) In this section—
8	(1) the term 'firefighter' means an employee
9	who—
10	"(A) is a firefighter within the meaning of
11	section 8331(21) or section 8401(14);
12	"(B) in the case of an employee who holds
13	a supervisory or administrative position and is
14	subject to subchapter III of chapter 83, but
15	who does not qualify to be considered a fire-
16	fighter within the meaning of section 8331(21),
17	would otherwise qualify if the employee had
18	transferred directly to such position after serv-

1	ing as a firefighter within the meaning of that
2	section;
3	"(C) in the case of an employee who holds
4	a supervisory or administrative position and is
5	subject to chapter 84, but who does not qualify
6	to be considered a firefighter within the mean-
7	ing of section 8401(14), would otherwise qualify
8	if the employee had transferred directly to such
9	position after performing duties described in
10	section 8401(14)(A) for at least 3 years; and
11	"(D) in the case of an employee who is not
12	subject to subchapter III of chapter 83 or chap-
13	ter 84, holds a position that the Office of Per-
14	sonnel Management determines would satisfy
15	subparagraph (A), (B), or (C) if the employee
16	were subject to subchapter III of chapter 83 or
17	chapter 84;
18	"(2) the term 'General Schedule base rate'
19	means an annual rate of basic pay established under
20	section 5332, before any additions such as a locality-
21	based comparability payment under section 5304 or
22	5304a or a special rate supplement under section
23	5305;
24	"(3) the term 'special base rate' means an an-
25	nual rate of basic pay payable to a wildland fire-

1	fighter, before any additions or reductions, that re-
2	places the General Schedule base rate otherwise ap-
3	plicable to the wildland firefighter and that is ad-
4	ministered in the same manner as General Schedule
5	base rates; and
6	"(4) the term 'wildland firefighter' means any
7	temporary, seasonal, or permanent position at the
8	Department of Agriculture or the Department of the
9	Interior, or Tribal Firefighters, that maintains
10	group, emergency incident management, or fire
11	qualifications, as established annually by the Stand-
12	ards for Wildland Fire Position Qualifications pub-
13	lished by the National Wildfire Coordinating Group,
14	and primarily engages in or supports wildland fire
15	management activities, including forestry and range-
16	land technicians and positions concerning aviation,
17	engineering heavy equipment operations, dispatch,
18	training, development and technology, or fire and
19	fuels management.
20	"(b)(1) Notwithstanding section 5332, a wildland
21	firefighter is entitled to a special base rate of pay at
22	grades 1 through 15 of the General Schedule, as pre-
23	scribed by this subsection. This special base rate shall re-
24	place the otherwise applicable General Schedule base rate
25	and shall be basic pay for all purposes, including the pur-

pose of computing a locality-based comparability payment under section 5304 or 5304a. Such special base rates shall 3 be computed as described in paragraphs (2) and (3) and 4 adjusted at the time of adjustments in the General Sched-5 ule. 6 "(2) The minimum rate of basic pay for any wildland firefighter in levels 1 through 5 of the General Schedule 8 shall— 9 "(A) be not less than the rate of pay for step 10 3 of GS-6, as adjusted by the pay locality des-11 ignated as 'Rest of U.S.' under section 5304; and 12 "(B) not be greater than the minimum rate of basic pay provided to GS-6 under paragraph (3). 13 14 "(3) The special base rates for a wildland firefighter 15 in levels 6 through 15 of the General Schedule shall be derived by increasing the otherwise applicable General 16 17 Schedule base rate on the date of enactment of this Act 18 by the applicable percentage for the wildland firefighter's 19 grade as shown below and rounding the result to the near-20 est whole dollar: "GS-6, 27 percent. 21 22 "GS-7, 24 percent. 23 "GS-8, 21 percent. 24 "GS-9, 18 percent. 25 "GS-10, 15 percent.

- 2 "GS-12, 9 percent.
- 3 "GS-13, 6 percent.
- 4 "GS-14, 3 percent.
- 5 "GS-15, 1.5 percent.
- 6 "(4) When the special base rate is expressed as an
- 7 hourly, daily, weekly, or biweekly rate, the rate is com-
- 8 puted from the appropriate annual rate of basic pay de-
- 9 rived under paragraph (2) or (3) in accordance with the
- 10 rules prescribed by section 5504(b).".
- 11 (b) Effective Date.—The amendments made by

16	(a) In General.—Title 5, United States Code, is
17	amended by inserting after section 5545b the following:
18	"§ 5545c. Incident standby premium pay for employ-
19	ees engaged in wildland firefighting
20	"(a) In this section—
21	"(1) the term 'covered employee' means an em-
22	ployee of the Forest Service or the Department of
23	the Interior who—

1	"(A) qualifies as a wildland firefighter
2	based on the definitions of 'firefighter' and
3	'wildland firefighter' in section 5332a(a); or
4	"(B) is certified by the applicable agency
5	to perform wildland fire incident related duties
6	during the period such employee is assigned to
7	a qualifying incident;
8	"(2) the term 'designated sleep and rest period'
9	means the hours during an incident deployment that
10	a covered employee is deemed to be in sleep or rest
11	status for pay computation purposes, regardless of
12	actual hours spent in that status;
13	"(3) the term 'incident standby premium pay'
14	means pay to which a covered employee is entitled
15	under subsection (c);
16	"(4) the term 'prescribed fire incident' means a
17	wildland fire originating from a planned ignition in
18	accordance with applicable laws, policies, and regula-
19	tions to meet specific objectives;
20	"(5) the term 'qualifying incident' means a
21	wildfire incident, a prescribed fire incident, or a se-
22	verity incident, but excludes an initial response inci-
23	dent involving a single operational period of less
24	than 36 hours (unless a longer period is approved by
25	an authorized agency official due to exceptional cir-

1	cumstances) if the employee is in continual work
2	status with no designated sleep and rest period es-
3	tablished by the agency;
4	"(6) the term 'severity incident' means an inci-
5	dent in which a covered employee is pre-positioned
6	in an area where conditions indicate there is a high
7	risk of wildfires; and
8	"(7) the term 'wildfire incident' means a
9	wildland fire originating from an unplanned ignition,
10	such as lightning, volcanos, unauthorized and acci-
11	dental human-caused fires, and prescribed fires that
12	are declared wildfires.
13	"(b) A covered employee is eligible for incident stand-
14	by premium pay under this section when meeting all of
15	the following conditions:
16	"(1) The employee is deployed to the field by
17	the employing agency to respond to a qualifying inci-
18	dent.
19	"(2) The employee is placed by the employing
20	agency in continuous duty status during the incident
21	deployment.
22	"(3) Any periods of sleeping and resting occur
23	in a field location associated with the duty assign-
24	ment.

1 "(c) A covered employee who meets the conditions in 2 subsection (b) is entitled to incident standby premium pay 3 for designated sleep and rest periods, and such pay shall 4 be the only compensation payable to the employee for those periods, notwithstanding any other law. Such premium pay shall be paid at an hourly rate equal to 50 per-6 cent of the employee's hourly rate of basic pay, rounded 8 to the nearest whole cent. In determining an employee's minimum wage and overtime pay entitlements under the 10 Fair Labor Standards Act, incident standby premium pay and associated hours shall be disregarded. 12 "(d) A covered employee's designated sleep and rest periods shall be fixed at 9 hours for every 24-hour duty 13 period associated with a qualifying incident, including nec-14 15 essary travel time. If the hours of an incident deployment are not an exact multiple of 24-hour periods, the ratio of 16 9/24 shall be multiplied by hours for the less-than-24hours period of duty to derive the designated sleep and 18 rest period for that duty period, with the result rounded 19 to the nearest fractional increment established by the 20 21 agency in tracking hours of work. 22 "(e) Incident standby premium pay under this sec-23 tion— 24 "(1) is not considered part of the basic pay of 25 an employee for any purpose;

1	" (2) may not be considered in determining an
2	employee's lump-sum payment for accumulated and
3	accrued annual leave under section 5551 or section
4	5552;
5	"(3) may not be used in determining pay under
6	section 8114 (related to workers' compensation); and
7	"(4) may not be considered in determining pay
8	for hours of paid leave or other paid time off during
9	which the premium pay is not payable.".
