# TITLE X—HUMANITARIAN FIREFIGHTER RELIEF ACT

#### 3 SEC. 1001. SHORT TITLE.

4 This title may be cited as the "Humanitarian Fire-5 fighter Relief Act".

#### 6 SEC. 1002. AMENDMENTS TO THE TARIFF ACT OF 1930.

and supplies to countries and organizations in need,
 as determined by the Secretary of the Treasury.";
 and

4 (4) by adding at the end the following new sen5 tence: "A qualified nonprofit organization referred to
6 in paragraph (5) is an organization that is described
7 in section 501(c)(3) of the Internal Revenue Code of
8 1986 and exempt from tax under section 501(a) of
9 such Code.".

(b) EFFECTIVE DATE.—The amendments made by
this section apply to articles entered, or withdrawn from
warehouse for consumption, on or after the 15th day after
the date of the enactment of this Act.
