Page 44, strike lines 7 through 13 and insert the following:

1 (1) by striking “If” and inserting “(a)(1) If the
2 Comptroller General or an executive agency deter-
3 mines that”;

4 (2) by striking “or an officer or employee of the
5 District of Columbia government”;

6 (3) by striking “or the Mayor of the District of
7 Columbia, as the case may be,”;

8 (4) by striking “the Comptroller General” and
9 inserting “the Comptroller General and the Attorney
10 General”; and

1 (5) by adding at the end the following:

Page 44, line 14, strike “(b)” and insert “(2)”.

Page 45, beginning on line 2, strike “or District of Columbia government”.

Page 45, beginning on line 7, strike “or District of Columbia government, as applicable,”.

3 lumbia government violates section 1341(a) or 1342 of
4 this title, the Mayor of the District of Columbia shall re-
5 port immediately to the President and Congress all rel-
6 evant facts and a statement of actions taken. A copy of
7 each report shall also be transmitted to the Comptroller
8 General on the same date the report is transmitted to the
9 President and Congress.”.

4 of the District of Columbia, as the case may be,”;

5 (4) by striking “the Comptroller General” and
6 inserting “the Comptroller General and the Attorney
7 General”; and

8 (5) by adding at the end the following:

Page 45, line 22, strike “(c)” and insert “(2)”.

Page 46, beginning on line 9, strike “or District of
Columbia government”.

Page 46, beginning on line 14, strike “or District of
Columbia government, as applicable,”.

Page 46, line 18, strike the closing quotation mark
and the second period.

Page 46, insert after line 18 the following:

9 “(c) If an officer or employee of the District of Co-
10 lumbia government violates subsection (a) of this section,
11 the Mayor of the District of Columbia shall report imme-
12 diately to the President and Congress all relevant facts
13 and a statement of actions taken. A copy of each report
14 shall also be transmitted to the Comptroller General on

1 the same date the report is transmitted to the President
2 and Congress.”.
