

**AMENDMENT TO RULES COMM. PRINT 119–8**  
**OFFERED BY MR. NUNN OF IOWA**

At the end of subtitle B of title XIII, insert the following:

1   **SEC. 13 \_\_\_\_ . ANNUAL REPORT ON TAIWAN CAPABILITIES**  
2                                   **AND INTELLIGENCE SUPPORT.**

3           Section 1248 of the National Defense Authorization  
4 Act for Fiscal Year 2022 (Public Law 117–81) is amend-  
5 ed—

6                   (1) in subsection (a)—

7                           (A) by striking “fiscal year 2027, the Sec-  
8 retary of State and the Secretary of Defense, in  
9 coordination with the Director of National In-  
10 telligence and the heads of other relevant Fed-  
11 eral departments and agencies, shall jointly”  
12 and inserting “fiscal year 2031, the Secretary  
13 of Defense, in consultation with the Secretary  
14 of State and the Director of National Intel-  
15 ligence, shall”;

16                           (B) in paragraph (2), by striking “ability  
17 of Taiwan” and inserting “readiness of the Tai-  
18 wan military”;

1 (C) by redesignating paragraph (16) as  
2 paragraph (19); and

3 (D) by adding after paragraph (15) the  
4 following:

5 “(16) An assessment regarding how Japan, the  
6 Republic of Korea, the Philippines, Vietnam, and  
7 Australia would likely respond to contingencies, in-  
8 cluding—

9 “(A) a military strike or invasion of Tai-  
10 wan or an offshore island of Taiwan, including  
11 Kinmen, Matsu, Wuciou, Taiping Island, and  
12 Penghu;

13 “(B) a commercial blockade of Taiwan in  
14 which international vessels are subjected to  
15 search or seizure by the People’s Liberation  
16 Army;

17 “(C) a major cyberattack against the crit-  
18 ical infrastructure of Taiwan; and

19 “(D) a seizure of one or more of Taiwan’s  
20 offshore islands or territorial claims.

21 “(17) Guidance for representatives from the  
22 military of Taiwan to attend, as observers and as  
23 appropriate, joint military exercises led by the  
24 United States, such as the biennial Rim of the Pa-  
25 cific exercise.

1           “(18) An assessment of the feasibility of using  
2           economic tools, including export controls, sanctions,  
3           and tariffs, to deter China from carrying out the ac-  
4           tions described in subparagraphs (A) through (D) of  
5           paragraph (16).”; and

6           (2) in subsection (b)—

7                 (A) in paragraph (2), by striking “; and”  
8                 and inserting a semicolon;

9                 (B) in paragraph (3), by striking the pe-  
10                riod at the end and inserting “; and”; and

11                (C) by adding at the end the following:

12                “(4) an assessment of how the United States  
13                Armed Forces could marshal resources to respond to  
14                the actions described in subparagraphs (A) through  
15                (D) of subsection (a)(16), based on the force posture  
16                and stockpiles of the Armed Forces.”.
