

**AMENDMENT TO
RULES COMMITTEE PRINT 117-54
OFFERED BY MR. O'HALLERAN OF ARIZONA**

At the end of subtitle __ of title __, insert the following:

1 **SEC. __. BLACKWATER TRADING POST LAND.**

2 (a) DEFINITIONS.—In this section:

3 (1) The term “Blackwater Trading Post Land”
4 means the approximately 55.3 acres of land as de-
5 picted on the map that—

6 (A) is located in Pinal County, Arizona,
7 and bordered by Community land to the east,
8 west, and north and State Highway 87 to the
9 south; and

10 (B) is owned by the Community.

11 (2) The term “Community” means the Gila
12 River Indian Community of the Reservation.

13 (3) The term “map” means the map entitled
14 “Results of Survey, Ellis Property, A Portion of the
15 West ½ of Section 12, Township 5 South, Range 7
16 East, Gila and Salt River Meridian, Pinal County,
17 Arizona” and dated October 15, 2012.

1 (4) The term “Reservation” means the land lo-
2 cated within the exterior boundaries of the reserva-
3 tion created under sections 3 and 4 of the Act of
4 February 28, 1859 (11 Stat. 401, chapter LXVI),
5 and Executive orders of August 31, 1876, June 14,
6 1879, May 5, 1882, November 15, 1883, July 31,
7 1911, June 2, 1913, August 27, 1914, and July 19,
8 1915, and any other lands placed in trust for the
9 benefit of the Community.

10 (5) The term “Secretary” means the Secretary
11 of the Interior.

12 (b) LAND TAKEN INTO TRUST FOR BENEFIT OF THE
13 GILA RIVER INDIAN COMMUNITY.—

14 (1) IN GENERAL.—The Secretary shall take the
15 Blackwater Trading Post land into trust for the ben-
16 efit of the Community, after the Community—

17 (A) conveys to the Secretary all right, title,
18 and interest of the Community in and to the
19 Blackwater Trading Post Land;

20 (B) submits to the Secretary a request to
21 take the Blackwater Trading Post Land into
22 trust for the benefit of the Community;

23 (C) conducts a survey (to the satisfaction
24 of the Secretary) to determine the exact acreage
25 and legal description of the Blackwater Trading

1 Post Land, if the Secretary determines a survey
2 is necessary; and

3 (D) pays all costs of any survey conducted
4 under subparagraph (C).

5 (2) AVAILABILITY OF MAP.—Not later than 180
6 days after the Blackwater Trading Post Land is
7 taken into trust under paragraph (1), the map shall
8 be on file and available for public inspection in the
9 appropriate offices of the Secretary.

10 (3) LANDS TAKEN INTO TRUST PART OF RES-
11 ERVATION.—After the date on which the Blackwater
12 Trading Post Land is taken into trust under para-
13 graph (1), the land shall be treated as part of the
14 Reservation.

15 (4) GAMING.—Class II and class III gaming
16 under the Indian Gaming Regulatory Act (25 U.S.C.
17 2701 et seq.) shall not be allowed at any time on the
18 land taken into trust under paragraph (1).

19 (5) DESCRIPTION.—Not later than 180 days
20 after the date of enactment of this Act, the Sec-
21 retary shall cause the full metes-and-bounds descrip-
22 tion of the Blackwater Trading Post Land to be
23 published in the Federal Register. The description
24 shall, on publication, constitute the official descrip-
25 tion of the Blackwater Trading Post Land.

1 (c) CERCLA COMPLIANCE.—In carrying out this
2 section, the Secretary shall comply with section 120(h) of
3 the Comprehensive Environmental Response, Compensa-
4 tion, and Liability Act of 1980 (42 U.S.C. 9620(h)).
