

AMENDMENT TO RULES COMMITTEE
PRINT 117-13
OFFERED BY MR. WALTZ OF FLORIDA

At the end of section LX of division E, insert the following:

1 **SEC. 6013. PROHIBITION ON CERTAIN SALES BY MEMBERS**
2 **OR SPONSORS OF THE OLYMPIC PARTNER**
3 **PROGRAMME OF THE INTERNATIONAL OLYM-**
4 **PIC COMMITTEE.**

5 (a) SALES PROHIBITION.—

6 (1) IN GENERAL.—Effective 60 days after the
7 date of the enactment of this section, a person that
8 is a member or sponsor of the Olympic Partner Pro-
9 gramme of the International Olympic Committee
10 may not sell any product made by such person on
11 a military installation.

12 (2) EXEMPTIONS.—

13 (A) TERMINATION OF MEMBERSHIP OR
14 SPONSORSHIP.—This section shall not apply
15 with respect to a person described in paragraph
16 (1) that terminates membership in, or sponsor-
17 ship of, the Olympic Partner Programme of the
18 International Olympic Committee at any time

1 before the end of the 30-day period after the
2 date of the enactment of this section.

3 (B) ALTERNATIVE SOURCE LIMITA-
4 TIONS.—This section shall not apply with re-
5 spect to a product if—

6 (i) a comparable product made by a
7 person described in paragraph (1) is not
8 available from an another source that is
9 authorized to sell such product on a mili-
10 tary installation; or

11 (ii) each comparable product that is
12 available from an another source that is
13 authorized to sell such product on a mili-
14 tary installation would increase the cost to
15 the consumer by 10 percent or more.

16 (b) DEFINITIONS.—In this section:

17 (1) MILITARY INSTALLATION.—The term “mili-
18 tary installation” has the meaning given such term
19 in section 2801 of title 10, United States Code.

20 (2) PERSON.—The term “person” means—

21 (A) a natural person, corporation, com-
22 pany, business association, partnership, society,
23 trust, or any other nongovernmental entity, or-
24 ganization, or group;

1 (B) any governmental entity or instrumen-
2 tality of a government, including a multilateral
3 development institution (as defined in section
4 1701(c)(3) of the International Financial Insti-
5 tutions Act (22 U.S.C. 262r(e)(3))); and

6 (C) any successor, subunit, parent entity,
7 or subsidiary of, or any entity under common
8 ownership or control with, any entity described
9 in subparagraph (A) or (B).

10 (c) TERMINATION.—This section and the require-
11 ments of this section shall terminate on—

12 (1) the date on which a determination is made
13 that the 2022 Olympic and Paralympic Winter
14 Games will not be held in the People’s Republic of
15 China; or

16 (2) September 30, 2025.
