

**AMENDMENT TO H.R. 7147**  
**OFFERED BY MR. PAPPAS OF NEW HAMPSHIRE**

At the end of the bill, before the short title, insert the following:

1        SEC. \_\_\_\_\_. (a) IN GENERAL.—Section 100052 of the  
2 Act titled “An Act to provide for reconciliation pursuant  
3 to title II of H. Con. Res. 14” (Public Law 119–21) is  
4 amended—  
5                (1) in the section heading, by striking “**U.S.**  
6                **IMMIGRATION AND CUSTOMS ENFORCEMENT**”  
7                and inserting “**COPS HIRING PROGRAM**”;  
8                (2) by striking “In addition to” and inserting  
9                “(a) IN GENERAL.—In addition to”;  
10               (3) in subsection (a), as so designated—  
11                        (A) by striking “Secretary of Homeland  
12                       Security for U.S. Immigration and Customs  
13                       Enforcement” and inserting “Attorney Gen-  
14                       eral”; and  
15                        (B) by striking “September 30, 2029” and  
16                       all that follows through “removal proceedings”  
17                       and inserting the following: “September 30,  
18                       2030, for grants made pursuant to paragraphs  
19                       (1) and (2) of section 1701(b) of the Omnibus

3       “(b) WAIVER.—For grants made from funds made  
4 available under this section, the requirements of section  
5 1701(g) of the Omnibus Crime Control and Safe Streets  
6 Act of 1968 (34 U.S.C. 10381(g)) shall be waived for the  
7 following jurisdictions:

8               “(1) A county, municipality, town, township,  
9               village, parish, borough, or other unit of general gov-  
10              ernment below the State level that employs fewer  
11              than 175 law enforcement officers.

12               “(2) A Tribal government that employs fewer  
13               than 175 law enforcement officers.”.

14 SEC. \_\_\_\_\_. Section 90003 of the Act titled “An Act  
15 to provide for reconciliation pursuant to title II of H. Con.  
16 Res. 14” (Public Law 119–21) is amended to read as fol-  
17 lows:

18 "SEC. 90003. EDWARD BYRNE MEMORIAL JUSTICE ASSIST-  
19 ANCE GRANT PROGRAM.

20        “In addition to any amounts otherwise appropriated,  
21 there is appropriated to the Attorney General for the De-  
22 partment of Justice for fiscal year 2025, out of any money  
23 in the Treasury not otherwise appropriated, to remain  
24 available until September 30, 2029, \$45,000,000,000, for

1 the Edward Byrne Memorial Justice Assistance Grant  
2 Program.”.
