At the end of subtitle C of title XVII, insert the following new section:

1 SEC. 17___. CERTAIN STATE SERVICE APPLICABLE FOR 2 FEDERAL FIREFIGHTERS WORKER'S COM 3 PENSATION.

4 Section 8143b(b) of title 5, United States Code, is
5 amended by adding at the end the following new para6 graph:

- 7 "(4) Reclassified firefighters.—
- "(A) IN GENERAL.—For the purposes of 8 9 determining the aggregate number of years an 10 individual has been employed as an employee in 11 fire protection activities under paragraph (1), 12 all periods in which such individual is or was 13 employed in a reclassified State position are 14 deemed to be periods in which such individual 15 was employed as an employee in fire protection 16 activities if such individual is or was appointed 17 to a position as an employee in fire protection 18 activities established by the Federal Govern-
