At the end of subtitle G of title V, insert the following new section:

1	SEC. 5 PORTABILITY OF PROFESSIONAL LICENSES OF
2	VETERANS AND THEIR SPOUSES.
3	(a) In General.—Title VII of the Servicemembers
4	Civil Relief Act (50 U.S.C. 4021 et seq.) is amended by
5	inserting after section 705A (50 U.S.C. 4025a) the fol-
6	lowing new section:
7	"SEC. 705B. PORTABILITY OF PROFESSIONAL LICENSES OF
8	VETERANS AND THEIR SPOUSES.
9	"(a) In General.—If a veteran or the spouse of a
10	veteran has a covered license and relocates residence not
11	later than 36 months after the date of the veteran's sepa-
12	ration from the Armed Forces to a State other than the
13	State of the licensing authority that issued the covered
14	license, such covered license shall be considered valid for
15	the scope of practice in the State of the new residence
16	if such veteran or spouse of a veteran submits to the li-
17	censing authority of such State an application described
18	in subsection (c).

1	"(b) Temporary Licenses.—If a licensing author-
2	ity is required to consider a covered license valid under
3	subsection (a) but cannot carry out such requirement dur-
4	ing the 30 days after receiving an application described
5	in subsection (c), the licensing authority shall issue to the
6	applicant a temporary license that confers the same rights,
7	privileges, and responsibilities as a permanent license.
8	"(c) APPLICATION.—An application described in this
9	subsection includes the following:
10	"(1) A copy of the veteran's DD Form 214 (or
11	successor form).
12	"(2) If the applicant is the spouse of a veteran,
13	a copy of—
14	"(A) the marriage certificate of such vet-
15	eran and spouse; and
16	"(B) military orders effectuating the sepa-
17	ration of the veteran that include the name of
18	such spouse.
19	"(3) A notarized affidavit affirming, under the
20	penalty of law, that—
21	"(A) the veteran or spouse of a veteran is
22	the person described and identified in the appli-
23	cation;
24	"(B) all statements made in the applica-
25	tion are true, correct, and complete;

1	"(C) the veteran or spouse of a veteran
2	has read and understands the requirements to
3	receive a license, and the scope of practice, of
4	the State of the licensing authority;
5	"(D) the veteran or spouse of a veteran
6	certifies that the veteran or spouse of a veteran
7	meets and shall comply with requirements de-
8	scribed in subparagraph (C); and
9	"(E) the veteran or spouse of a veteran is
10	in good standing in all States in which the vet-
11	eran or spouse of a veteran holds or has held
12	a license.
13	"(d) Background Checks.—A licensing authority
14	that receives an application described in subsection (c)
15	may conduct a background check of the veteran or spouse
16	of a veteran before carrying out subsection (a) or (b).
17	"(e) Definitions.—In this section:
18	"(1) The terms 'covered license', 'license', 'li-
19	censing authority', 'military orders', and 'scope of
20	practice' have the meanings given such terms in sec-
21	tion 705A of this Act.
22	"(2) The term 'veteran' has the meaning given
23	such term in section 101 of title 38, United States
24	Code.".
