At the end of title VII, add the following new section:

SEC. 7____. EXPANSION OF AVAILABILITY OF FINANCIAL ASSETS OF IRAN TO VICTIMS OF TERRORISM. (a) FINDINGS.—Congress makes the following find-

4 ings:

5 (1) On October 23, 1983, terrorists sponsored
6 by the Government of Iran bombed the United
7 States Marine barracks in Beirut, Lebanon. The ter8 rorists killed 241 servicemen and injured scores
9 more.

10 (2) Those servicemen were killed or injured11 while on a peacekeeping mission.

12 (3) Terrorism sponsored by the Government of
13 Iran threatens the national security of the United
14 States.

(4) The United States has a vital interest in ensuring that members of the Armed Forces killed or
injured by such terrorism, and the family members
of such members, are able to seek justice.

1	(b) Amendments.—Section 502 of the Iran Threat
2	Reduction and Syria Human Rights Act of 2012 (22
3	U.S.C. 8772) is amended—
4	(1) in subsection $(a)(1)$ —
5	(A) in subparagraph (A), by striking "in
6	the United States" the first place it appears
7	and inserting "by or";
8	(B) in subparagraph (B), by inserting ",
9	or an asset that would be blocked if the asset
10	were located in the United States," after
11	"unblocked)"; and
12	(C) in the flush text at the end—
13	(i) by inserting after "in aid of execu-
14	tion" the following: ", or to an order di-
15	recting that the asset be brought to the
16	State in which the court is located and
17	subsequently to execution or attachment in
18	aid of execution,"; and
19	(ii) by inserting ", without regard to
20	concerns relating to international comity"
21	after "resources for such an act"; and
22	(2) in subsection (b)—
23	(A) by striking "that are identified" and
24	inserting the following: "that are—
25	"(1) identified";

1	(B) by striking the period at the end and
2	inserting "; and"; and
3	(C) by adding at the end the following:
4	"(2) identified in and the subject of proceedings
5	in the United States District Court for the Southern
6	District of New York in Peterson et al. v. Islamic
7	Republic of Iran et al., Case No. 13 Civ. 9195
8	(LAP).".
9	(c) Report.—
10	(1) IN GENERAL.—Not later than 90 days after
11	the date of the enactment of this Act, the Director
12	of National Intelligence shall submit to Congress a
13	report on threats against the United States military
14	and defense interests, personnel, and their families,
15	posed by organizations that are designated by the
16	Secretary of State as a foreign terrorist organization
17	pursuant to section 219 of the Immigration and Na-
18	tionality Act (8 U.S.C. 1189) with connections to
19	the Government of Iran, as determined by the Direc-
20	tor.
21	(2) FORM.—The report under paragraph (1)
22	shall be submitted in unclassified form, but may
23	contain a classified annex.
